

# Bloomberg Politics – Purple Slice Poll Voters with HH Incomes of \$100K+ Conducted by Purple Strategies Survey Topline September 2016

#### **METHODOLOGY**

Purple Insights conducted 600 interviews nationwide of likely voters with household incomes of \$100,000 or more between September 16 and 19, 2016. The poll was conducted online, using an opt-in nationally representative panel. The margin of error is +/-4.0 percentage points and higher for subgroups.
