I am writing to file a formal complaint, a serious breach of the Equal Time Rule.

The Federal Communications Commission's equal-time rule was established in 1934 and requires radio and television broadcast stations to provide the same amount of time. In addition, a serious breach of the Equal Time Rule by NBC DFW 4805 Amon Carter Blvd.

Fort Worth, TX 76155, which aired an episode of "Saturday Night Live" featuring Vice President Kamala Harris just days before Election Day. This unprecedented move not only raises profound questions about media ethics but also poses a clear violation of the regulations that govern fair media practices in our democratic process.

The Equal Time Rule is a cornerstone of our democratic system, designed to ensure that all candidates receive equitable exposure and opportunity in the media. By granting such a prominent platform to the Vice President, particularly within the critical window before a major election, sources say, NBC has blatantly favored her candidacy while disregarding its obligation to provide equal time to her opponents, including former President Donald Trump, Jill Stein, and Robert F. Kennedy Jr.

This situation is not merely an oversight; it is a deliberate act that undermines the principles of fairness and impartiality that are vital to the integrity of our elections. The public airwaves belong to the people, and it is unacceptable for a major network to manipulate the political landscape to serve the interests of one candidate over others.

I urge the FCC to take immediate and decisive action to investigate this violation. The integrity of our electoral process demands that all candidates, regardless of party affiliation or status, be granted equal opportunities to reach voters. It is essential that the FCC reassert its authority and ensure compliance with the Equal Time Rule to preserve the democratic ideals upon which our nation was founded.

Given the significant impact of such appearances on public perception, I urge the FCC to investigate whether NBC complied with Equal Time requirements and whether other candidates were offered similar exposure on SNL or any other comparable platform. A prompt review and clear guidance on this issue would help reassure the public that all candidates are given a fair and unbiased opportunity to reach audiences through broadcast channels.

Thank you for your attention to this matter. I trust that the FCC will act to uphold the principles of fair access to the airwaves for all candidates.
