### **Benchmark Regulation**

- >> On September 10th, Sean Tompkins was a presenter on Bloomberg's European Benchmark Regulation Webinar seen <a href="here">here</a>. The webinar focused on Bloomberg's EU BMR product offering and how FIGI, an open source identifier, can be used to reconcile index data discrepancies.
- >> Identification of benchmarks and indicies has been a long standing problem for the industry, with current legislation (EMIR BMR) bringing the challenge into particular focus. Research provided to regulatory authorities and the industry highlighted that FIGI has close to, if not complete 100% coverage across the market, in comparison to results showing numbers topping out around 15% coverage for other identifiers like ISIN (According to Bloomberg data).
