SUMMARY

This report summarizes the results of an investigation conducted by the U.S. Securities and Exchange Commission's (SEC) Office of Inspector General (OIG) into allegations of threats by (b)(6): (b)(7)(C) directed against Chair Gary Gensler and other past and present SEC officials. The Office of Security Services (OSS) referred voicemails containing potential threats. The initial communications were indirect threats which escalated into direct threats toward Chair Gensler, Florida law enforcement officers and SEC OIG senior special agents.

RESULTS OF INVESTIGATIVE ACTIVITY

Allegation #1: (b)(6) Threatened Chair Gensler

On April 20, 2022, we received an e-mail from Security Specialist (b)(6); (b)(7)(C) OSS, transmitting three phone calls with voicemails from the TAPS. The caller stated, in reference to Chair Gensler, "I hope all of you have bodyguards when you walk out of the front doors because your heads should be taken off. You're going to get shot. Gary (Gensler), you're going to get f***ed up. You're going to get killed Gary. If I don't chop you up, someone else will." OSS believed that (b)(6); (b)(7)(C) initiated these calls from his cellular phone. (EXHIBIT 1)

On April 20, 2022, and April 28, 2022, we obtained Consolidated Lead Evaluation and Reporting (CLEAR) and National Crime Information Center (NCIC) reports for (b)(6): Using this data, we tentatively identified (b)(6): as the April 20, 2022, caller. (EXHIBIT 2)

The investigation was initiated based on a referral from the Office of Security Services (OSS) of a voicemail containing a potential threat.

We determined that the call was made from a telephone number assigned to (b)(6); (b)(7)(C) The caller stated, in reference to Chair Gensler, "If I see him in public, I will beat his fucking teeth down his asshole." When we contacted (b)(6); he neither admitted nor denied making the call threatening Chair Gensler. (b)(6); was advised and acknowledged understanding the potential consequences of future calls of a threatening nature.

The facts and details of this investigation were presented to the United States Attorney's Office, which declined to prosecute. We coordinated with OSS to provide (b)(6): identity and photograph for awareness and distribution, if deemed necessary.



On Wednesday, August 10, 2022, at 1757 hours, (b)(6),(b)(7)(C) contacted me via e-mail, which included two audio recordings attached to it, regarding inappropriate communication from SUBJECT to the US Congressman's office located at the Kenneth Keating Federal Building and U.S. Courthouse, 100 State St., Rochester, NY.

I listened to the audio which contained the voice of a man, who identified himself as SUBJCT and stated, "I am proabortion if it is retroactive to Barack Obama, Joe Biden, Chuck Schumer, and Joe Morelle". I had the Philadelphia Mega Center conduct a National Criminal Information Center Check on SUBJECT for wants/warrants and a criminal history report. The check did not contain any information pertinent to my preliminary investigation. I also had the Monroe Crime Analysis Center conduct a background check on SUBJECT which also contained nothing pertinent to my preliminary investigation.

On Tuesday, August 23, 2022, at 1441 hours, after I returned from a weeklong training course, I followed up with with a phone interview. I asked [[]] if he felt threatened by this phone call. [[]] advised me that he did not feel threatened and that he reported this call out of an abundance of caution. []] also added that their office phone records go back to year 2020 and this is the first contact that he can find from SUBJECT.

After obtaining the necessary information, I briefed my supervisor, the Federal Protective Service Special Agent in Albany, NY, and the US Capitol Police officer assigned to this case, with my findings. The determination made was that no further action is required of the Federal Protective Service at this time. I advised (INCOLORIZED) to contact me if the Congressman's office receives additional inappropriate communication from SUBJECT and action will be taken at that time, if necessary.

SUMMARY OF INVESTIGATION

On September 29, 2022, FPS Investigations Branch was notified SUBJECT allegedly threatened a Social Security Administration (SSA) employee via telephone in violation of Title 42 U.S. Code § 1320A – 8B.

On September 29, 2022, Region 8, Federal Protective Service (FPS), Investigations Branch (IB) initiated an investigation after receiving information SUBJECT threaten a Social Security Administration employee located at 275 Corporate Drive, Suite D, Kalispell, Montana via telephone.

On September 29, 2022, SUBJECT contacted the Kalispell SSA via telephone concerning a benefits payment issue. While being serviced by the SSA representative, SUBJECT became agitated and stated she was going to "go postal." After the representative attempted to calm her down, SUBJECT further stated, "if I don't get my money...people in the government are going to pay with their lives." SUBJECT then disconnect the call. SSA Manager (b)(6),(b)(7)(C) immediately reported the incident to Kalispell Police, FPS, and SSA-OIG. Inspector (b)(6),(b)(7)(c) conducted an NCIC query of SUBJECT and coordinated with Kalispell Police to contact SUBJECT. Kalispell Police advised SUBJECT is considered "transient" and they were unable to locate her. SSA requested SUBJECT be issued a no trespass advisement by Kalispell Police upon future contact and subsequently mailed a ban letter to her last known address. In coordination with Assistant United States Attorney (b)(6),(b)(7)(C) (AUSA, District of Montana) and SSA-OIG, a (b)(7)(E)(b)(7)(E)On October 18, 2022, SA [bi6](bi(7)(c)] interviewed SUBJECT via telephone. SUBJECT related her comments were out of frustration with her SSA benefit payments which have since been resolved. During the interview SUBJECT revealed she has attempted to buy a firearm in the past but was not allowed due to a mental condition prohibition. Additionally, SUBJECT stated the FBI has stolen money from her and she would inflict harm on NANCY PELOSI if she were to contact her (b)(7)(E)(b)(6)(b)(7)(c) requested an in-person interview in Kalispell, MT, to which SUBJECT initially agreed. On October 26, 2022, SA (b)(6)(b)(7)(c), and Inspector (b)(6)(b)(7)(c) attempted locate SUBJECT in the Kalispell area. SA (b)(6)(b)(7)(c) and Inspector (b)(6)(b)(7)(c) visited SUBJECT's recent addresses in Kalispell but were unable to locate her.

On October 18, 2022, SUBJECT contacted SA ((b)(6),(b)(7)(C) via phone (Call received from (b)(6),(b)(7)(C) at 1:47 pm and lasted approximately 9 minutes). SUBJECT identified herself and related she did have a conversation with an SSA representative on September 29, 2022, via phone regarding her benefits.

When SUBJECT was asked if she intended to harm anyone at the SSA she responded, "Not yet." SUBJECT did not recall specifically what she said to the SSA representative but related her pay issue has since been resolved and her comments were out of frustration.

SUBJECT further stated her main issue was with the "FBI" and the "thousands of dollars" they have "stolen" form her. SUBJECT stated she used to work at a "racetrack in Pennsylvania" approximately 15 years ago where she assisted the FBI in a "corruption" investigation.

SUBJECT further requested SA [(b)(6),(b)(7)(c)] investigate "Dr. Fauci and Nancy Pelosi" for the crimes they were committing against America. SUBJECT stated she would "tie Nancy Pelosi's limbs to four horses and watch them tear her apart" if she ever found her in Montana.

SUBJECT also stated she attempted to "buy a gun at Nicks" but was denied because of her time in a mental health facility in 2009. SUBJECT contributed this denial to the FBI conspiracy against her.

SUBJECT related she has recently found a permanent residence in Kalispell, MT and would be open to additional follow-up interviews.

On October 27, 2022, SA (b)(6),(b)(7)(c) conducted a follow-up interview over the phone with SUBJECT. SUBJECT provided her updated mailing address but declined to be interviewed in-person.
