- 1.) Upper Dempsey pump #1 (U501391 Lower Cedar Grove) was not operational during the inspection period. Pump has been pulled to facilitate repairs. Permittee to diligently pursue repairs.
- 2.) Grants Branch (U503897) one pump ~3k GPM was operational through outlet 008. A second pump ~3k GPM was operational through outlet 012, during the inspection period.
- 2.) Pie pump #1 associated with Alma A (U503897) was not operational during the inspection period.
- 3.) Thacker pump associated with Alma A (U503897) was not operational during the inspection period.
- 4.) Permit wide road system maintenance and their associated drainage systems need maintenance.
- 5.) Island Creek Drill Site Project: Drilling began October 20, 2021 and was completed on October 21, 2021. LoMing Pool Levels Drill Site report provided 05/26/2022 and attached.

CORRECTIVE ACTION PLAN PER CONSENT ORDER DATED AUGUST 16, 2021 PERTINENT TO SHOW CAUSE #2039

WEEKLY REPORT (5-26-22)

Per the subject Consent Order, a weekly report is to be submitted on the progress of the items below as specified in the Order until such items are fully completed. These items are:

- Reduce mine pool level to a compliant elevation.
- Submit a Corrective Action Plan in the form of a permit revision demonstrating how mine pool elevations will be maintained at compliant levels to include operable backup pumps as needed in order to prevent adverse impacts to the public and environment.
- Initiate measures to provide a Probable Hydrologic Consequences (PHC) update to include Water Quantity/Water Quality/Water Discharge information with respect to the hydrologic balance associated with said permit.

MINE POOL/PUMPS:

The latest available mine pool reading at Grant Branch was **±1180.69'**. Six pumps have been utilized over the past +10 years to control the mine pool. Their status is as follows:

Grant Branch Pump #1 (1300 gpm): This pump needs major repairs. The original quote to repair the pump has now been paid however due to recent price jumps since that quote was issued, the supplier has issued a second quote to cover the extra costs. Supplier has revised the second quote and a PO has been requested to cover the additional cost. We are currently awaiting delivery of the pump and associated supplies; delivery has been delayed.

Grant Branch Pump #4 (3000 gpm): This pump is currently operating.

Grant Branch Pump #5 (3000 gpm): This pump is currently operating.

Thacker Branch Pump #1 (1800 gpm): This pump is currently off.

<u>Pie Pump #1:</u> The wiring from the power pole has been vandalized and needs replaced. AEP has cut power to this pump due to an invoice conflict. AEP power needs restored prior to fixing wiring to avoid additional vandalism.

<u>Upper Dempsey Pump #1</u>: Pump motor went down. A boom truck will be needed to pull the motor off and evaluate further. Access road has been repaired; the motor has been removed from the pump. Pump will need to be repaired prior to installing a replacement motor. Awaiting bids to replace the parts.

CORRECTIVE ACTION PLAN:

A Corrective Action Plan (CAP) was submitted 08/23/21 as Revision #22. Corrections issued 08/31/21 and resubmitted on 09/02/21. Second correction set issued 09/07/21 and resubmitted 09/07/21.

PROBABLE HYDROLOGIC CONSEQUENCES:

As described in Revision #22, PHC updates were included in previously approved IBR #25 and recently approved IBR #27.

Construction work has been completed at the pond site.

The initial drill hole was completed on 10/21/21.

<u>Supplemental Information Pertaining to Administrative Orders issued to U503897 and U501391</u> Regarding John Hatfield Complaint:

This information is provided as directed in an MR-6 and is to be included with the Weekly Report going forward until this field work is completed.

Lexington Coal Company was found to be responsible for water artesianing out of John Hatfield's water well. Lexington personnel met with John Hatfield and Inspector Mike Rose. The following items were agreed upon to address Mr. Hatfield's concerns:

1. Mr. Hatfield has two water wells located close to each other in a cinderblock housing. It was agreed that the well closest to the outbuilding will be sealed via grouting. A water line/spigot combination will be installed on the other well with the spigot on the outside of the housing. Additionally, a water line/hose will be placed near the spigot and then buried along a route that goes behind the outbuilding, between the outbuilding and a vacant house (also owned by Mr. Hatfield), and then ran through the yard over to the creek bank. This system will allow for any future artesianing water to be captured and controlled through the spigot/water line system and discharged out to the creek thereby avoiding any potential property damage to Mr. Hatfield's house or structures.

Lexington personnel talked to Mr. Hatfield on 08-25-21 and informed him of efforts to have utility lines in the work area marked (request has been made via Miss Utility). Advised him that work is anticipated to be done in mid to late September. This work schedule too will depend on completing the Lo-Ming project. Construction of the drill pad is now underway and should come to an end soon. Lexington personnel visited Mr. Hatfield on 10-12-21 and relayed the planned work schedule to him. Lexington personnel received the right of entry back from Mr. Hatfield, it will need to be recorded at the courthouse prior to any work being performed. Equipment and supplies will be scheduled for delivery to site on a later date. Lexington personnel is postponing any contact with the heirs of Mr. Hatfield's estate to allow a sufficient time of mourning.
