Summary:

USSS/PID/OSB social media analysis discovered the following planned demonstrations scheduled to take place in Washington, DC on 1/6/21. As group numbers are obtained, PID will provide updates. The demonstration activity is summarized below:

1. From 11/19/20 to 01/31/21, **Women for a Great America (NRID)** will host a demonstration at Lafayette Park. The purpose of the demonstration is to pray for a peaceful election. There is no indication of civil disobedience. The permit application indicates 50 expected participants.
2. From 01/04/21 at 10:00 AM to 01/06/21 at 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host and event called "**Carpool to Washington, DC**" at the White House. The purpose of the event is to carpool from Texas and arrive in Washington, DC on 01/05/21. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 0 are interested.
3. From 01/05/21 at 6:00 AM to 01/07/21, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "**BTT heads to Washington DC for Trump Victory Rally**" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 8 people are going, and 27 are interested.
4. On 01/05/21 at 6:30 AM to 01/07/21 at 7:00 AM, the group **Muskegon County Republican Party (NRID)** will host an event called "**Muskegon Bus to DC – Tyump Rally Jan 6th - Stop The Steal**" at the US Capitol. The purpose of the event is to take a bus from Muskegon to Washington, DC to support President Trump. There is no

indication of civil disobedience. According to Facebook, 19 people are going, and 51 are interested.

5. From 01/05/21 at 07:00 AM to 01/07/21 at 7:00 AM the group **Oakland County Republican Party (NRID)** will host a demonstration called "**March For Trump**" in Washington, D.C. The group plans to leave from Michigan on January 5th to arrive in Washington D.C. at 9:00 AM on January 6th. The purpose of this event is to join the pro-Trump demonstrations. Post permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Participants are encouraged to bring flags and signs. Bus tickets are being sold for \$125 through Eventbrite. The group plans to stay in DC until 6:00 PM on January 6th. Facebook indicates 10 going and 15 interested.
6. On 01/05/21 at 9:00 AM to 01/12/20 at 9:00 AM, the individual (b)(6); (b)(7)(C) **(NRID)** will host a demonstration called "**Protect the POTUS**" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, 3 people are going, and 8 are interested.
7. From 01/05/21 at 10:00 AM to 01/06/21 at 08:00 PM, the individual (b)(6); (b)(7)(C) **(NRID)** will host a demonstration called "**March on Congress Caravan**" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC from Florida and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 8 people are going, and 6 are interested.
8. On 01/05/21 from 10:00 AM to 01/07/21 at 2:00 AM, the group **The First Heavy Metal Church of Christ (NRID)** will host an event called, "**Patriots Part 2020 in D.C.**" in Washington, DC. The group plans to leave on 01/05/21 and caravan to DC, stay at the Grand Hyatt and protest all day on 01/06/21. The purpose of the event is to show support for the Nation. There is no indication of civil disobedience. According to Facebook, 10 people are going, and 49 are interested.
9. On 01/05/21 at 6:00 PM to 01/06/21 at 9:00 PM, the group **Wisconsin Salt & Light Brigade (NRID)** and individual (b)(6); (b)(7)(C) **(NRID)** will host a demonstration called "**Stop the Steal!**" in Washington, DC. The purpose of the event is to "save our country from Biden/China tyranny!" There is no indication of civil disobedience. According to Facebook, 3 person is going, and 5 are interested.

10. On 01/05/20 at 10:00 PM to 01/07/21 at 10:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called **"FREE bus trip DC for the Jan 6 protest!"** in Washington, DC. The purpose of the event is to bus to Washington, DC to participate in the protest to support President Trump. There is no indication of civil disobedience. According to Facebook, 14 people are going, and 82 are interested.
11. On 01/05/21 at 11:30 PM to 01/06/21 at 8:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called **"Charter Bus to Trump Rally, DC"** at the US Capitol. The propose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook 21 people are going, and 120 are interested.
12. On 01/06/21, at an unknown time, **Proud Boys (RID)** will host an unnamed demonstration in Washington DC. The purpose of this demonstration is to join the pro-Trump demonstrations. There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants was not indicated, but the group stated they will "turn out in record numbers." **Proud Boys** is of record for numerous demonstrations at the White House and temporarily protected sites. Their demonstrations have concluded without arrests.
13. On 01/06/21, at an unknown time, **Refuse Fascism (RID)** will host a demonstration in Washington DC called **"Opposing Trump's Moves to Overturn the Election."** The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There was no indication of civil disobedience. Current numbers of planned participants was not indicated at this time.
- **Refuse Fascism** is of record for protesting at the White House, Lafayette Park, and numerous temporarily protected sites. One demonstration from 2017 ended with arrests for disorderly conduct and failure to obey.
14. On 01/06/21, at an unknown time, the group **DC Protests (NRID)** will host a demonstration with an unknown title in Washington, DC. The purpose of the event is to form a bike line to "protect against the armed right-wing extremist groups." The group plans on forming a bike line using bikes, boards, and wheels. The specific location was not provided. There is no indication of civil disobedience. Participant numbers were not available.
15. On 01/06/21, at 12:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called **"National Caravan for Trump 'Stop the Steal' Rally"** at the US Capitol. The purpose of the event is to join the caravan to protest in Washington, DC. There is no

indication of civil disobedience. According to Facebook, 1 person is going and 0 are interested.

16. On 01/06/21 at 11:00 AM, **Fred Hampton Gun Club (NRID)** and **Not Fucking Around Coalition (RID)** will host a demonstration at Black Lives Matter Platter called "US Against Racism." The purpose of the demonstration is "keeping our people and property safe." There is no mention of civil disobedience. The event flyer claims frontline "must have tactical gear/bullet proof vest." There is no indication to the amount of participants
 - **Not Fucking Around Coalition (NFAC)** is of record with the service following a heavily armed protest in Louisville, KY in 2020
17. On 01/06/21 at 1:00 AM, the individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "We the people need transparency!" at the US Capitol. The purpose of the event is to "show up outside the senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 3 person is going, and 5 are interested.
18. On 01/06/21, from 1:00 AM to 12:55AM, the individual (b)(6), (b)(7)(C) (NRID) and group **Patriot Party of America (The Peoples Party) (NRID)** will host a demonstration called "Million MAGA Strong" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 people are going, and 14 are interested. _
19. On 01/06/21, from 4:00 AM to 11:45PM, the individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "CANTON/AKRON ELECTION PROTEST BUS TRANSPORTATION (SOLD OUT)" at the US Capitol. The group plans on leaving Canton, OH and demonstrating in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 66 people are going, and 183 are interested. _
20. On 01/06/21, from 5:00 AM to 5:00 PM (b)(6), (b)(7)(C) (NRID) and (b)(6), (b)(7)(C) (NRID) will host a rally at Freedom Plaza in Washington, DC called "Bus Trip to D.C. Last Rally for Freedom." The purpose of the event is to support President Trump and Vice President Michael Pence on this momentous day in history as Congress counts the Electoral College's votes. The page did not indicate there would be any civil disobedience. The page portrayed 19 participants and 42 interested.
21. On 01/06/21, at 5:30 AM, the individuals (b)(6), (b)(7)(C) (NRID) and (b)(6), (b)(7)(C) (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Jan 6th DC MAGA/KAG March-leaving from Fayetteville, NC" at the US Capitol. The group plans on leaving various places in North Carolina and arrive in Washington, DC at 10 AM. The purpose of the

demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 22 people are going, and 66 are interested.

22. On 01/06/21, from 5:45 AM to 4:00 PM, (b)(6); (b)(7)(C) (NRID) will be hosting an event at the United States Capitol called "**Road (Bus) Trip to DC.**" The purpose of the event is to join in the "WILD PROTEST" in support of President Trump scheduled for the day. There is no mention of civil disobedience. All chatter on the page pertain to tickets for the bus trip. Current numbers according to Facebook, 82 going and 283 interested.
23. On 01/06/21, at 6:00 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) (NRID) will host a demonstration called "**#StopTheSteal Rally for America – Bus trip**" in Washington, DC. The purpose of the demonstration is to petition Congress to follow the constitution and the will of the people. There is no indication of civil disobedience. According to Facebook, 27 people are going, and 40 are interested.
24. On 01/06/21, at 6:30 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "**NC Stop the Steal caravan to DC**" in Washington, DC. The purpose of the event is to Caravan from NC to Washington to attend the Stop the Steal rally. There is no indication of civil disobedience. According to Facebook, 12 people are going, and 37 are interested.
25. On 01/06/21, from 6:00 AM to 8:00 PM, the groups **Upcoming Events All Over The World (NRID)**, **Capitol Hills (NRID)**, and **Stop The Steal Jan 6 Capitol Hill 2021 (NRID)** will host an event called "**2021 Stop The Steal Jan 6 Capitol Hill Live**" at 1st Street NE. The purpose of the event is to "Stand up for America and Stop The Steal." There is no indication of civil disobedience. According to Facebook, 1 people are going, and 0 are interested.

On 01/06/21, from 6:00 AM to 11:00 PM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (b)(6); (b)(7)(C) (NRID) will host a demonstration called "**Fight for Trump_ van from Winston Salem NC to DC**" in Washington, DC. The purpose of the demonstration is to march for President Trump. There is no indication of civil disobedience. According to Facebook, 56 people are going, and 135 are interested.
27. On 01/06/21, at 7:00 AM time, **Women for America First (NRID)** and **March for Trump (NRID)** will host a demonstration in Washington DC called "**March for Trump**" at the Ellipse in President's Park. The purpose of this demonstration is to "demand transparency & protect election integrity." There was no indication of civil disobedience. Current numbers of planned participants was unavailable at this time.

On 01/06/21, at 7:00 AM, **American Conservatism (NRID)** will host a demonstration at the U.S. Capitol called "**March on Congress.**" The purpose of this demonstration is to speak out against election fraud and in support of President Trump. There was no indication of civil disobedience. Facebook currently indicates 1.2K are going and 5K are interested.
29. On 01/06/21, at 7:00 AM, the group **The Proud Patriot Party (NRID)** will host a demonstration called "**Fight For Trump**" at the White House. The purpose of this event is to show support for President Trump. There are no discussion posts available on the page at this time. Facebook indicates 1 going and 1 interested.
30. On 01/06/21, at 07:00 AM, the group **RI Warriors for Trump (NRID)** will host a demonstration called "**TRUMP RALLY DC**" in Washington D.C. Specific location has not yet been released. The purpose of the event is to "demand transparency and protect election integrity." There is no indication of civil disobedience. Post permissions for the group's discussion section have been turned off. According to Facebook, 26 people are going, and 31 are interested.
31. On 01/06/21, at 7:00 AM, the group **New Jersey Patriots Event Page (NRID)** and the individual (b)(6); (b)(7)(C) **(NRID)** will host a demonstration called "**Million MAGA March, March for Trump, StopTheSteal**". The purpose of the demonstration is "President Trump has called for all of his supporters to be in Washington, D.C. January 6th – This will be the biggest protest in American History. The time to take a stand is now!" There is no indication of civil disobedience. Facebook currently indicates 905 are going and 2.3K are interested.
32. On 01/06/21 from 7:00 AM to 10:00 AM, the group **Trumpaigun (NRID)** will host a demonstration called "**March on Congress**" at the US Capitol. The purpose of the event is to demand the politicians to confirm Donald Trump as President. There is no indication of civil disobedience. According to Facebook, 31 people are going, and 68 are interested.
33. On 01/06/21, from 07:00 AM to 09:00 PM, the individual (b)(6); (b)(7)(C) **(NRID)** will host a demonstration called "**Support Trump MAGA....**" in Washington D.C. Specific location has not yet been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. Post permissions for the group's discussion section have been turned off. According to Facebook, 1 going and 1 interested.

The purpose of the event is to "come to DC Jan 6 when Congress counts electoral votes and objections are raised." There is no indication of civil disobedience. According to Facebook, 131 person is going, and 225 are interested.

Upon the declaration the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There

is no indication of civil disobedience. Facebook currently indicates 9 people are planning to attend and 34 are interested.

83. On 01/06/21, at 12:00 PM, the individual (b)(6), (b)(7)(C) (NRID) and (b)(6), (b)(7)(C) (NRID) will host a demonstration called "**Stop the Steal March #BeThere**" in Washington, DC. The purpose of the event is to make politicians listen. There is no indication of civil disobedience. According to Facebook, 353 people are going, and 894 are interested.
84. On 01/06/21, at 1:00 PM, **Insurgence USA (NRID)** and **Protest Live (NRID)** will host a demonstration in Washington DC called "**No Fascist in DC – March Against Fascism.**" The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There was no indication of civil disobedience. Facebook currently indicates 9 are going and 82 are interested.
85. On 01/06/21, at an unknown time, **They Them Collective (RID)**, **Total Liberation Collective (NRID)**, **DC Protests (NRID)**, **Good TroubleCo.op (NRID)**, **Smash the Fash NOVA (NRID)**, and **DC Youth Liberation Front/DCYLF (RID)** will host a demonstration in Washington DC called "**Alert: Terrorists in Town Jan 3-6, 17-23.**" The purpose of this demonstration is to speak counter demonstrate during the Proud Boys (RID) and Stop the Steal demonstrations. There was no indication of civil disobedience. Current numbers of planned participants was not indicated at this time.
- **TheyThem Collective** is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.
 - **Youth Liberation Front**, is of record for a demonstration on 08/13/20 near Meridian Park. An unknown number of arrests were made for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows. Arrests were not indexed as there was no PI nexus.

Protective Intelligence Brief

March for Trump

Background

Since the 2020 election, demonstrations have been organized nationwide advocating for President Trump and speaking out against the election results. In November 2020, a pro-Trump gathering in Washington, DC, resulted in an estimated 11,000 participants at Freedom Plaza, who marched to the Capitol and Supreme Court, and in December 2020, another pro-Trump gathering in Washington, DC, resulted in approximately 3,000 participants. The Pro-Trump protesters split between Freedom Plaza, the National Mall, the Capitol and the Supreme Court, with some individuals marching from one place to another, while others protested in one spot. For additional information, please refer to the PID After Action Talking Points the [Million MAGA March After Action Nov 16 2020 \(dhs.gov\)](#) and [PID Briefing Document - March for Trump 12-12 Event \(After Action\).docx \(dhs.gov\)](#) for additional information regarding these previous demonstrations.

The November and December demonstrations resulted in verbal and physical altercations between pro and anti-Trump demonstration groups, as well as numerous arrests. During the November 14, 2020, demonstration the Metropolitan Police Department (MPD) reported 21 arrests for assault, assault on a Police officer, possession of a weapon, disorderly conduct, and inciting violence. There were also seven firearms recovered by MPD during this event. The December 12, 2020, demonstration resulted in 33 arrests for assault on a police officer, simple assault, riotous acts, possession of a prohibited weapon (taser) and crossing a police line. MPD also reported during this event there were four people stabbed during an altercation, which included one MPD officer. All of the victims received non-life-threatening injuries and were treated and released.

Individuals continue to speak out against the 2020 presidential election results, and pro-Trump supporters have begun to organize another large-scale demonstration to occur on January 6, 2021. This is the day Congress is scheduled to certify the Electoral College vote for President-elect Joe Biden. As momentum for the demonstrations increased, President Trump tweeted to encourage his supporters to come to DC and protest, writing, "Be there, will be wild!" Individuals chose this tagline for the upcoming protest, naming it the "Wild Protest." The hashtag #WildProtest has been widely used to discuss and promote the event. President

Trump tweeted again on December 27, 2020, promoting the protest. As of December 30, 2020, social media indicated **4,280** participants plan to attend, and an additional **12,621** are interested.

Organizers

Stop The Steal (NRID), *Million MAGA March (NRID)*, *Women for America First (NRID)*, *March for Trump (NRID)*, *Proud Boys (RID)*, and other pro-Trump groups, along with private citizens, have promoted event pages for the event.

Stop The Steal is a loosely organized group which emerged on November 7, 2020, with the belief the election is being stolen from President Trump due to election fraud. The group began organizing demonstrations nationwide called "Stop The Steal." According to the website, invited speakers and featured guests for the January 6, 2021 event include Rep. Paul Gosar, Ali Alexander, Roger Stone, Rep-Elect Marjorie Greene, Rep. Lance Gooden, Rep-Elect Lauren Boebert, State Rep. Vernon Jones, State Rep. Mark Finchem, State Sen. Doug Mastriano, State Rep. Anthony Kern, and several others. One spokesperson from Stop The Steal, Ali Alexander (NRID), has encouraged followers to bring tents, sleeping bags, food, and water. Alexander claimed, "if DC escalates...so do we. Do not wear a mask. Stand with others bullied by staff." Twitter removed this tweet as it violated the spread of COVID-19 harmful information.

The Million MAGA March has been involved in organizing both large protests in November and December. The website was created early November prior to the first Million MAGA March, which spurred several social media groups and pages supporting this movement.

Women for America First is a pro-Trump, female led group. The group was the center of organization for both the November and December protests. The group plans to host a "March for Trump" bus tour from California to Washington, DC, arriving on the January 6, 2021.

Although March for Trump is listed as a group, several different smaller factions are listed under this name. The group name is considered more of a movement than an organization.

Proud Boys is a right-wing group founded in 2016 by Gavin McInnes as a "pro-Western fraternal organization." They are of record with USSS for demonstration activity since 2017; no civil disobedience or arrests have been recorded. For more information on the Proud Boys, please see the [Protective Intelligence Brief Proud Boys Talking Points](#).

Hotel Harrington, an alleged hangout/hotel for the Proud Boys, made a statement on December 28, 2020, announcing their closure from January 4-6, 2021, for "safety of visitors and employees." According to news media, four individuals were stabbed outside the hotel during the protests on December 12, 2020, when Proud Boys members clashed with counter protesters. Proud Boys' self-proclaimed chairman, Enrique Tarrio (NRID), made a statement on Parler regarding the closing of Hotel Harrington, claiming the Proud Boys outgrew the hotel and are planning on protesting during the January 4-6, 2021, time frame and will be staying at various other locations.

Call to Protest

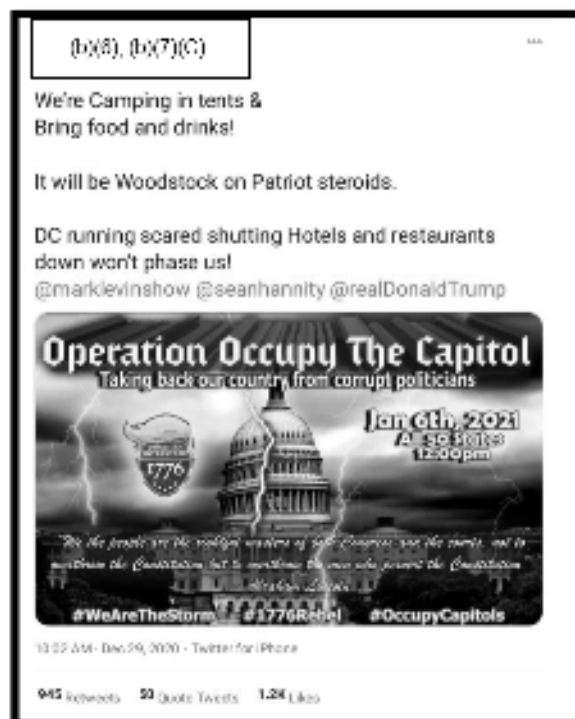
On January 6, 2021, a consortium of private citizens and pro-Trump groups reportedly will host the Wild Protest in Washington, DC. The groups intend to demonstrate in support of President Trump and speak

out against the 2020 election results. Numerous groups have claimed to be protesting at the US Capitol, with other groups protesting at the White House.

The hashtags #WeAreTheStorm, #1776Rebel, and #OccupyCapitols have gained attention as the protest on January 6, 2021 approaches. Commenters argue that other individuals were able to occupy other areas, including Black Lives Matter Plaza and the Capitol Hill Organized Protest/Capitol Hill Autonomous Zone, during separate protests, so President Trump supporters have proposed a movement to occupy Capitol Hill. This movement is supported by Ali Alexander's video requesting individuals to bringing tents, food, sleeping bags, and water (which has received over 300 comments and 2.5K retweets). Individuals who cannot come to Washington, DC, are encouraged to occupy their local capitols.

A website was located for chats and events related to the January 6th, 2021 DC Protest, titled *Maga Drag the Interstate*. Through this site, users are able to submit/create event caravan pages. All events are currently in reference to car and motorcycle caravans. There are currently 511 members for the "Jan 6 DC Caravan Planning" group with 47 events starting from all over the United States and reportedly ending in Washington, DC.



From January 5, 2021, at 6:00 AM, to January 7, 2021, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 7 people are going, and 25 are interested.

From January 5, 2021, at 10:00 AM, to January 6, 2021, at 08:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC, from Florida, and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 5 people are going, and 5 are interested.

On January 5, 2021, at 10:00 AM to January 7, 2021 at 2:00 AM, the group *The First Heavy Metal Church of Christ* (NRID) will host an event called, "Patriots Part 2020 in D.C." in Washington, DC. The group plans to caravan to DC, stay at the Grand Hyatt, and protest all day. The purpose of the event is to show support for the nation. There is no indication of civil disobedience. According to Facebook, 6 people are going, and 39 are interested.

On January 5, 2021, at 10:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *New Jersey Patriot Events* (NRID) will host a demonstration called "Washington DC 5th - 6th Trip" at the National Mall. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 89 people are going, and 250 are interested.

On January 6, 2021, at an unknown time, the *Proud Boys (RID)* will host an unnamed demonstration in Washington, DC. The purpose of this demonstration is to join the other pro-Trump demonstrations. There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire, and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers."

On January 6, 2021, at 1:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "We the people need transparency!" at the US Capitol. The purpose of the event is to "show up outside the senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 1 person is going, and 6 are interested.

On January 6, 2021, from 1:00 AM to 12:55 AM, the individual (b)(6); (b)(7)(C) (NRID) and group *Patriot Party of America (The Peoples Party) (NRID)* will host a demonstration called "Million MAGA Strong" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 people are going, and 14 are interested.

On January 6, 2021, from 4:00 AM to 11:45 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "CANTON/AKRON ELECTION PROTEST BUS TRANSPORTATION (SOLD OUT)" at the US Capitol. The group plans on leaving Canton, OH, and demonstrating in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 59 people are going, and 182 are interested.

On January 6, 2021, at 11:00 AM, the individual (b)(6); (b)(7)(C) (NRID) and the group *THE BASKET OF DEPLORABLE* (NRID) will host an event called "Jan 6th D.C. Maga March" in Washington, DC. The purpose of the event is to join "the largest Maga March Ever!" There is no indication of civil disobedience. According to Facebook, 10 people are going, and 19 are interested.

On January 6, 2021, at 12:00 PM, the group *Eat Pray Kill* (NRID) will host a demonstration called "Election Fraud and Electoral College Protest" at First St NE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 4 people are going, and 11 are interested.

On January 6, 2021, at 12:00 PM, the group *Fight for Freedom and Trump Rally* (NRID) will host a demonstration called "Fight For Freedom Trump Rally" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 People are going, and 5 are interested.

On January 6, 2021, at 12:00 PM, the group *Washington State March for Trump in DC 01/06/2020* (NRID) will host a demonstration called "MARCH FOR TRUMP" in Washington DC. The specific location has not been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. According to Facebook, there are 0 going, and 1 interested.

On January 6, 2021, at 12:00 PM, the group *Million MAGA March* (NRID) will host a demonstration at the National Mall in Washington, DC, called "Million MAGA March – Round III." The purpose of this demonstration is to show support for President Trump and speak out against the election results. The group is utilizing hashtags #millionmagamarch, #millionmagamarch2021, and #stopthesteal. There was no indication of civil disobedience. Their website currently indicates 1,090 people are going.

On January 6, 2021, at 12:00 PM, the group *Patriot Party* (NRID) and private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the US Capitol called "Patriots United March on Congress." The purpose of the demonstration is to speak out for election integrity while Congress meets to confirm the Electoral College votes. The group indicates plans to meet at the Capitol, but has not indicated potential routes. There is no indication of civil disobedience. According to Facebook, 34 people are going, and 212 are interested.

According to Facebook, 6 people are going, and 7 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and groups *Virginia Women for Trump (NRID)*, *Keep Georgia Red (NRID)*, *TRUMPS FREEDOM FIGHTERS (NRID)*, *PRESIDENT DONALD TRUMPS SOLID SUPPORT WORLDWIDE (NRID)*, *Women United for Trump (NRID)*, *Trump/Pence Reelection Group (NRID)*, *Trump Daily Report (NRID)*, *TRUMP ~ The Next Four Years (NRID)*, and *GA Women for Trump (NRID)* will host a demonstration called "MARCH FOR TRUMP JANUARY 6" WASHINGTON DC" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 13 people are going, and 23 are interested.

On January 6, 2021, at 12:00 PM, an unknown group will host a demonstration titled "Operation Occupy The Capitol" in Washington, D.C. The purpose of the event is to "peacefully protest the election fraud." Participants are encouraged to protest at their state capitol if they are unable to travel to Washington D.C. There is no indication of civil disobedience at this time. The Twitter event hashtags are #WeAreTheStorm, #1776Rebel and #OccupyCapitols. Participant numbers are unknown as the event was located through flyer.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Stop the Steal March #BeThere" in Washington, DC. The purpose of the event is to "make politicians listen." There is no indication of civil disobedience. According to Facebook, 192 people are going, and 732 are interested.

On January 6, 2021, at an unknown time, the groups *Women for America First (NRID)* and *March for Trump (NRID)* will host a demonstration in Washington DC called "March for Trump." The purpose of this demonstration is to "demand transparency & protect election integrity." There is no indication of civil disobedience. Current numbers of planned participants are unavailable at this time.

Counter Demonstrations

There are several counter-demonstrations planned for January 6, 2021. OSB has observed less social media activity and chatter for these counter-demonstrations than during previous pro-Trump demonstrations. The themes emerging from social media chatter amongst the counter protestors is similar to the rhetoric espoused during prior protests; the groups are attempting to keep Proud Boys and other Pro-Trump groups out of Washington, DC.

Several local groups have shared the news regarding Hotel Harrington closing from January 4-6, 2021, and have encouraged followers to contact other local hotels to encourage them to shut down as well. Although *ShutDownDC (RID)*, *All Out DC (RID)*, and *Black Lives Matter DC (RID)*, have shared the news regarding Hotel Harrington on social media, they have not publicly announced any details regarding plans to protest.

On January 6, 2021, at an unknown time, the group *Refuse Fascism (RID)* will host a demonstration in Washington, DC, called "Opposing Trump's Moves to Overturn the Election." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, at an unknown time, the groups *They Them Collective (RID)*, *Total Liberation Collective (NRID)*, *DC Protests (NRID)*, *Good TroubleCo.op (NRID)*, *Smash the Fash NOVA (NRID)*, and *DC Youth Liberation Front/DCYLF (RID)* will host a demonstration in Washington, DC, called "Alert: Terrorists in Town Jan 3-6, 17-23." The purpose of this demonstration is to counter demonstrate during the Proud Boys and Stop the Steal demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, from 12:00 PM to 3:00 PM, the group *I Approve This Message (NRID)* will host a demonstration at the US Capitol Building called "Donald, You're Fired! March on DC." The purpose of the demonstration is to "witness this momentous occasion. Upon the declaration of the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There is no indication of civil disobedience. According to Facebook, 7 people are going, and 20 are interested.

On January 6, 2021, at 1:00 PM, the groups *Insurgence USA (NRID)* and *Protest Live (NRID)* will host a demonstration in Washington, DC, called "No Fascist in DC – March Against Fascism." The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There is no indication of civil disobedience. According to Facebook, 7 people are going, and 63 are interested.

Refuse Fascism has demonstrated on numerous occasions at the White House and temporary protected sites. One demonstration in 2017, held near Trump Tower in New York City, ended with arrests for disorderly conduct and failure to obey.

TheyThem Collective is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.

DC Youth Liberation Front is of record with the USSS for a demonstration in August 2020 near Meridian Park. The group utilized sound equipment and MPD made several arrests for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows.

ShutDownDC has demonstrated on numerous occasions in relation to social justice in Washington, DC, as well as outside Acting DHS Secretary Chad Wolf's home. A ShutDownDC demonstration on June 2, 2020, resulted in one arrest for possession of an imitation pistol and a BB gun.

All Out DC is of record with the USSS for numerous demonstrations at the White House. During an All Out DC demonstration in June 2020, protestors were observed using fireworks, obstructing roads, and throwing debris at officers. MPDC used smoke to clear the area and the demonstration concluded with one arrest for threats.

Black Lives Matter has demonstrated on numerous occasions at the White House and temporary protected sites. The group has previously used sound equipment. One demonstration on June 4, 2020,

concluded with one arrest after gas cans and fireworks were observed inside a subject's vehicle. Two arrests were made during a demonstration on June 2, 2020, for possession of an imitation pistol and possession of a BB gun.

Dark Web

No organization efforts for events on January 6, 2021, have been identified on the dark web at this time.

Road Closures

MPDC has not made an official announcement regarding any road closures at this time.

Assessment

Many of the groups planning to engage in demonstration activities on January 6, 2021, are the same which participated in demonstration activities on November 14, 2020, and December 12, 2020. Verbal and physical altercations ensued between pro-Trump and anti-Trump supporters during both events. (b)(5)

Issue: NPS Permit# 21-0278 Women For America First

Program: WASO – Visitor and Resource Protection – United States Park Police

Key Points:

- The Women For America First will assemble on the Ellipse on January 6, 2021 for a First Amendment demonstration to protest the results of the 2020 elections.
- Expected attendance is around 5,000 participants.
- POTUS is expected to speak at the event at approximately 1100 hours.
- Previous similar First Amendment demonstrations have led to wide-spread violence in the downtown DC area.

Background:

On January 6, 2021, Congress will hold a joint session to formally certify the electoral votes from the 2020 election. It is expected that some members of Congress will object to the election results that the Biden-Harris ticket won the election. Numerous First Amendment demonstrations are expected in the downtown DC area to protest the results of this election. On November 14, 2020 and December 12, 2020, similar protests occurred. In both instances wide-spread violence occurred in the downtown DC area, perpetrated by both sides of the political spectrum.

Schedule of Events (January 6, 2021) (U//LES)

- 0500 hours: First wave of USPP personnel report for assignment.
- (b)(7)(E) USSS/USPP security sweeps begin.
- 0700 hours: Gates open to general public.
- 0900 hours: Rally begins.
- 1100 hours: POTUS arrival/POTUS remarks.
- TBD: POTUS departure.
- 1630 hours: Event concludes.

NPS Impact

- NPS areas impacted will include President's Park and the National Mall and Memorial Parks.
- NPS should expect higher than normal visitation with both pro and counter groups occupying NPS reservations.
- USPP, in coordination with the Metropolitan DC Police Department, will enact both no parking restrictions and road closures in the following areas on NPS jurisdiction:
 - Madison Drive between 3rd Street and 14th Street NW

On 01/06/21, Congress will vote to certify the electoral college results. Approximately fifty different groups have indicated they will demonstrate in Washington, DC. Past encounters between opposing protest groups have occasionally led to violence between them and against law enforcement personnel. Attached is an overview of notable trends and tactics recently observed, which should be considered ahead of potential civil unrest in the National Capital Region. PID has issued multiple Protective Intelligence products since June 6, 2020, concerning threats to law enforcement personnel and civil unrest. Reference is made to previously published PID products documenting officer safety and protest tactics, as follows:

(U) Notable Trends and Tactics for Consideration Ahead of Potential Civil Unrest in the National Capital Region

January 4, 2020

(U) Executive Summary

On January 6th, 2021, a joint session of Congress will meet on Capitol Hill to certify the votes of the Electors to the Electoral College from each state in the Union. Large groups of demonstrators are anticipated to travel to Washington, DC in advance of the vote. Past encounters between opposing protest groups have occasionally led to violence between them and against law enforcement personnel, as well as damage to private and government property. Roughly 26 demonstration permits have been approved by the US Park Police for January 5-7, including Freedom Plaza, Washington Monument, the National Mall Area and the Capitol, and several hotels are sold out on January 5-6, both indicators of large crowds. Permit application estimates indicate there could be approximately 28,000 people in attendance for these events. At least 55 additional demonstrations have been mentioned on social media for January 6, but it is unclear whether any are permitted.

The Proud Boys (RID), a group who is of record for numerous demonstrations at the White House and temporarily protected sites, have advised they will not wear their traditional black and yellow attire and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers." The group has not been known to engage in civil disobedience and their demonstrations have ended without incidents or arrests.

(U) Recent Events Featuring Violent Tactics

On Saturday, 12/12/20, at least eight officers sustained injuries during violent altercations after a Million MAGA March rally in DC as objects were thrown and officers were assaulted. Multiple assaults took place between protestors and four individuals were stabbed after an argument escalated. Shields, eye gear, helmets, armor, pepper spray, and a variety of weapons were utilized by the opposing sides.

- In Sacramento, individuals threw objects at officers and some deployed pepper spray. Individuals from opposing protest groups wore gas masks, helmets, and armor.
- In Olympia, WA, officers were assaulted by objects including rocks, a baton, and a paintball gun. Individuals from opposing groups possessed firearms and one individual was arrested in connection to a shooting. Additionally, a large firework IED that failed to detonate was found in the area which had to be rendered safe by the state bomb squad.

On Saturday, 12/05/20, three Sacramento officers suffered minor injuries during dueling protests which saw thrown objects and lasers shone into officers' eyes.

On Saturday, 11/14/20, during clashes after the Million MAGA March rally between pro-Trump supporters and counter protesters, four DC police officers were injured while intervening in fights and keeping the opposing sides separate. There were reports of objects being thrown, including rocks and bottles. One protestor was stabbed and transported to the hospital.

On Saturday, 10/31/20, two San Francisco officers were assaulted with caustic chemicals during a free speech rally when counter protesters threw bottles filled with the substance. Officers reported trouble breathing and burning sensations. Glass bottles, cans, and eggs were also thrown.

Three Percenters



The Three Percenters (aka III%ers) is an American right-wing movement created in 2008 based on the belief that only three percent of American colonists were willing to take up arms against the British during the American Revolution. Followers draw parallels between the colonial grievances leading to the American Revolution and modern-day perceptions of government overreach and interference with personal freedoms. Supporters tout the ability of a small force capable of overthrowing an unjust government. Some groups have formed based on the Three Percenter ideology, like the III% Security Force or the Sons of Liberty, and many individuals associated with the movement have joined with already established groups, like the Oath Keepers, a right-wing militia organization.

Online, Three Percenters claim they are not a militia, not a paramilitary group, and not anti-government but created to “reign in an overreaching government and push back against tyranny” by serving as a last defense for US citizens. Like other patriot groups, some Three Percenters propagate conspiracy theories, such as the establishment of a global world order which seeks to systemically deprive Americans of their Constitutional rights.

Activities

During the 2020 election cycle and following the 2021 inauguration, domestic violence extremists, including militias, advocated for violence against those individuals they considered to be their political opponents. They also called on others to arm themselves against what they perceive to be an increasingly illegitimate government.

During the Trump Administration, Three Percenters attended protests that saw the ideological left and right in opposition to one another on prominent issues such as police brutality and COVID-19 lockdowns. Typically, Three Percenters offered to act as a civilian protection service and peacekeeper by peacefully protesting, often while armed.

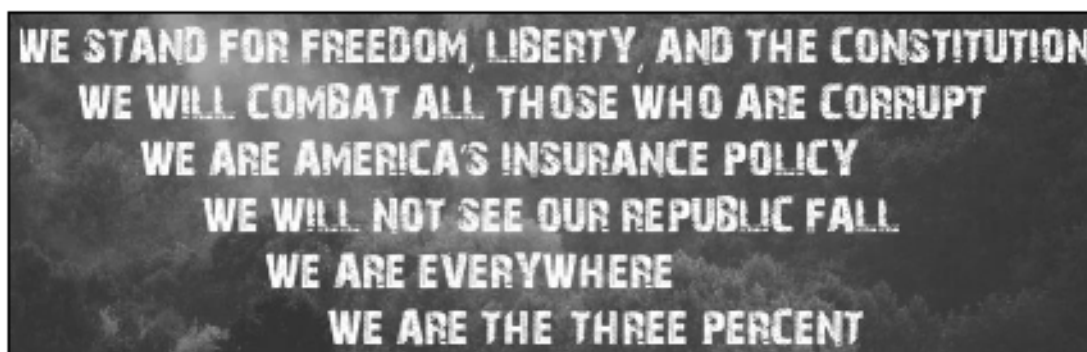

They have previously provided security for local events supportive of former President Trump and right-wing protests, to include the 2017 Unite the Right rally in Charlottesville, VA.

During these events, Three Percenters branded themselves as opposition to violence from ideological opponents, such as Antifa, and avoided aligning themselves with white supremacist groups. Violent confrontation at the 2017 Unite the Right Rally prompted Three Percent leaders to issue "stand down" orders to their followers, further distancing the movement from racists groups. While members have engaged in verbal altercations during protest activity in recent years, violent altercations are rare.



Some individuals claiming affiliation with the movement have conducted or planned attacks garnering widespread media attention:

- In 2018, members of the Illinois-based White Rabbit Three Percenters were arrested for multiple weapons violations. The group was behind the firebombing of a mosque, the attempted firebombing of an abortion clinic, an armed home invasion posing as police officers, and armed robberies at Walmart.
- In 2020, members of the Michigan-based Wolverine Watchmen were arrested for plotting to kidnap the governor of Michigan. One of their members was alleged to be a leader within the Three Percenter movement and had their symbol tattooed on his hand.
- On January 17, 2021, (b)(6); (b)(7)(C) who is black, was arrested near the US Capitol Building after he approached the National Guard to ask about taking pictures. He admitted to a police officer he had a firearm and loaded magazine. (b)(6); (b)(7)(C) denied group affiliation, but said people should "rise up against tyranny" and possessed a Three Percenter flag. (b)(6); (b)(7)(C) claimed he was there to photograph concrete barriers being used for security.

The Three Percenters are of record with the USSS for two peaceful demonstrations since 2014. A few individuals of record with the USSS have claimed an affiliation with the Three Percenters. One record documented a member of the Wisconsin Three Percenters who was alleged to have threatened President Obama. The USSS and the FBI investigation determined the accusation was unfounded and made as a result of discontent within the group, including civil litigation.

Individuals who claim affiliation with the Three Percenter movement took part in the January 6 US Capitol Building breach, which saw individuals break into the Capitol building and attack officers resulting in dozens of injuries and five deaths, including a USCP officer. Conspiracy charges have not been brought against Three Percenter followers, but the possibility of their coordinated involvement exists. A Three Percenter arrested for involvement in the breach posted Facebook photos of him posing with a Three Percenter flag and clothing and was discovered to run a private paramilitary training group in Colorado. Another individual, whose wife stated he was a member of a Three Percenter group, reportedly threatened his children if his involvement was reported to the police, which he considered it traitorous activity.

Outlook

A National Terrorism Advisory issued by DHS on January 27 judged domestic violent extremists may feel emboldened following the January 6 US Capitol Building breach to target elected officials and government facilities. Days prior, on January 15, a California man was arrested for possession of multiple fully-operational pipe bombs, 49 firearms, to include a suspected belt fed machine gun, and materials used to manufacture explosive devices. The man, who had a Three Percenter sticker on his vehicle, sent text messages after January 6 about his desire to target Democrats and a willingness to go to "war." In response to the DHS advisory, members of a prominent militia forum promoted conspiracy theories regarding false-flag attacks to target right-wing individuals and possibility of Vice President Harris assuming the presidency.

QAnon

Background

The QAnon movement began in late 2017 on 4chan when Q, an anonymous official, posted former First Lady Hillary Clinton would be arrested because of her involvement in child sex trafficking. Q claimed to have a government Q security clearance and insider knowledge of secret government activities. Since then, QAnon has been defined as a loosely connected community of conspiracy theorists who believe the deep state exists for several reasons. The theory of a deep state is its own separate conspiracy theory that has existed for decades. However, QAnon believes the deep state enables a cabal of elites to control the government in ways that conceal their criminal activities and benefit their special interests.

While QAnon's core belief is that a group of Satan-worshiping elites, who run a child sex ring, are trying to control US politics and the media, their adoption of the deep state theory has enabled any anti-government conspiracy theory to be added. For example, QAnon followers have claimed the deep state was responsible for mass shootings and election engineering. They have also theorized COVID-19 is related to the wave spectrum used by 5G technology and COVID-19 vaccines are used to implant microchips into the population to make people compliant.

(example at left). These cryptic posts often consist of *non sequitur conclusions* or statements that suggest deep state activity. Former President Trump became a cult hero within the QAnon movement due to his campaign language about rooting out the corruption in Washington, DC. QAnon adherents describe political attacks against former President Trump as deep state plots. In 2017 and 2018, QAnon followers claimed the Russian collusion investigation by Special Counsel Robert Mueller was a front for former President Trump's investigation into the deep state.

The proliferation of QAnon conspiracies into mainstream politics has resulted in some individuals running for elected office in order to expose the deep state. Two individuals elected to Congress in 2020 have expressed support for QAnon.

Other notable QAnon related incidents are as follows:

- On November 2, 2020, a QAnon channel on Telegram released a post adorned with images of the Proud Boys, Patriot Action Network, the Oath Keepers, and the Three Percenters along with an announcement of a supposed meeting of “patriot groups” in Florida to discuss action for the US presidential election. There is no indication such a meetup occurred.
- On October 22, 2020, a QAnon Telegram channel shared an opinion article written by former General Michael Flynn, in which he claimed there was a “leftist” and “elitist takeover” thwarting the “will of the American people.”
- On March 13, 2019, a member of a New York crime family was fatally shot outside his Staten Island residence. Police charged (b)(6); (b)(7)(C) whose exact motive is not clear, but some open source reporting indicates a connection to QAnon ideology. (b)(6); (b)(7)(C) displayed QAnon slogans on his hand and claimed to be a follower of QAnon. A month earlier (b)(6); (b)(7)(C) was investigated after visiting a courthouse where he explained he wanted to arrest two Members of Congress he blamed for illegal immigration. (b)(6); (b)(7)(C) said former First Lady Clinton, Speaker Pelosi, and others were responsible for election fraud and child sex trafficking. (b)(6); (b)(7)(C)

- In November 2018, a local police officer working security in Hollywood, FL, was photographed wearing a QAnon patch as Vice President Pence spoke to officers at the conclusion of a visit. Once the image was shared on Vice President Pence’s twitter it was circulated online stoking controversy. The post was taken down and the officer was reprimanded and reassigned.
- In June 2018, a man blocked the Hoover Dam access road and initiated a standoff during which he held a sign in his vehicle that read, “Mr. President release the reports.” After a peaceful end, the man wrote a letter to the USSS that included the QAnon slogan, “Where we go one, we go all.”

Despite its origins as a conspiracy theory with a predominantly US nexus, the movement has spawned an international following leading to localized hybridization of the conspiracy narrative. This lends credence by reinforcing the widespread nature and reach of the deep state to QAnon believers.

- On October 22, 2020, a German-language QAnon channel posted a photo depicting political leaders, on both the left and the right, in a noose. The same channel posted altered photos of former President Trump placing a noose around the necks of former President Obama and former First Lady Clinton.

On January 6, 2021, QAnon supporters were among the individuals who breached the US Capitol Building during the Congressional certification of the electoral ballots for President-elect Biden. An individual dubbed, the "QAnon Shaman," is one of many facing charges. An individual, reported to be a Qanon supporter, was fatally shot by US Capitol Police while climbing through a broken interior window.

Another QAnon supporter, was seen in a viral video wearing a distinctive Q shirt. He advised the FBI that he intentionally positioned himself toward the front of the mob so his T-shirt would be visible to the cameras so Q would "get the credit."

Outlook

The FBI has labeled QAnon a domestic terrorist movement because of their unpredictable beliefs and anonymous nature. For law enforcement officials seeking to prevent future violent attacks, the rise of QAnon has presented new challenges because many QAnon conspiracy theories cut across political divides and propagate quickly online. QAnon beliefs have spread to other anti-government extremist groups and movements.

Proud Boys

Background

The Proud Boys is a right-wing group founded in 2016 that has chapters throughout North America and Europe. Its first leader, founder of *Vice* Gavin McInnes, described the group as a “pro-Western fraternal organization” formed in response to the “war on masculinity” with an “anti-political correctness and anti-racial guilt” agenda. Members take a pledge which states, “I am a Western Chauvinist and I Refuse to Apologize for Creating the Modern World. The West is the Best.” Two years later, McInnes disavowed the Proud Boys accusing it of being taken over by white supremacists in the aftermath of the group’s participation in the Unite the Right rally in Charlottesville, VA, in mid-2017.



The Proud Boys, and its current leader Enrique Tarrio, claim they do not discriminate based on race, sexual orientation, or sexual preference; however, some supporters have made anti-Muslim, misogynistic, transphobic, and white supremacist comments online and while participating in protests alongside white supremacist groups. Proud Boys are led by a leadership council, referred to as the Elder Chapter, but much of the public personality of the group is shaped by its leader. Open and law enforcement sources suggest the organizational structure to be hierarchal, with the Elder Chapter setting policy, membership requirements, and overall direction; however, local chapters appear to retain autonomy for activities at the local level with individuals participating in national “all calls” at their discretion.

Proud Boys members wear a black “Fred Perry” polo shirt with gold piping. Proud Boys have been increasingly adding paramilitary gear to augment their Fred Perry shirts, such as plate carriers, load bearing equipment and helmets. The change in equipment appears to be developing on an individual level in response to clashes with left-wing opponents at demonstrations that turned violent in mid-Summer 2020.



Activities

Proud Boys have organized several public events bringing them into contact and conflict with groups on the left. Individuals seem to participate at their discretion regardless of leadership stance. An example occurred in the lead-up to the 2017 Unite the Right rally when then-leader McInnes denounced the event and discouraged Proud Boys from attending in "colors," yet several members participated in the infamous torch light march across campus.

The Proud Boys have also organized rallies to draw other right-wing support. As an example, they held rallies to "End Domestic Terrorism (EDT)," in Portland, OR, in both 2019 and 2020 that drew media coverage. The 2019 event resulted in violent confrontation with left-wing extremists including Antifa adherents that ended with 13 arrests. The second EDT rally was held in September 2020 following more than 100 uninterrupted nights of riots by left-wing groups in Portland, OR, who were protesting police brutality. Although clashes with Antifa supporters were expected, the rally concluded without any significant incidents reported. The Proud Boys clashed again during demonstrations in August 2020 when a Proud Boys member allegedly fired several paint balls at rival protesters. He was arrested and charged with 12 counts involving assault and unlawful use of a weapon among other charges.

The Proud Boys have collaborated with other right-wing movements, although these partnerships may not necessarily reflect a change in the group's ideology. In one such collaboration, the Proud Boys announced support for the "March Against Human Trafficking and Pedophilia" rally which was largely based on the [QAnon conspiracy theory](#).

Proud Boys are of record with the USSS for seven demonstrations since 2017 in support of former President Trump. No civil disobedience or arrests were recorded.

The Proud Boys have been involved in many activities surrounding the 2020 election, such as their participation in the mid-November 2020 "Million MAGA March." Many of their social media posts about the election contained vague threats of violence.

Prior to the January 6 US Capitol Building breach, the Proud Boys leader, Tarrío, was arrested by the Metropolitan (DC) Police Department on charges stemming from his burning a Black Lives Matter flag. During his arrest, Tarrío was in possession of two unloaded rifle magazines branded with the Proud Boys logo. He was released and barred from the District until his hearing in June 2021. After the Capitol breach, Tarrío released a statement encouraging followers to join the "Stop the Steal" rally and to avoid wearing their trademark Fred Perry shirts to avoid detection. Media reports claimed the Proud Boys had a large presence at the rally. Several Proud Boys were identified inside the US Capitol Building, one of whom smoked a cigar he later referred to as a "victory smoke."

Outlook

A National Terrorism Advisory issued by DHS on January 27 judged domestic violent extremists may feel emboldened following the January 6 US Capitol Building breach to target elected officials and government facilities. In the short-term, the Proud Boys will have to respond to the revelation that Tarrío was once a police informant. While the Proud Boys are not necessarily anti-law enforcement, it is not clear how this will affect the group moving forward. Some Proud Boys chapters have announced they are breaking away from the national organization. Tarrío has released a statement indicating the national Elder Chapter and the local chapters are still working out differences.

While the Proud Boys approved of former President Trump, they were not organized around him nor did they use former President Trump as the center piece of their ideology. (b)(5); (b)(7)(F)

Patriot Front



Background

Patriot Front is an American white supremacist, nationalist group that uses imagery of patriotism, liberty, and other widely accepted American values to promote its ideology. The group split off from Vanguard America in August 2017 in the aftermath of the Unite the Right rally in Charlottesville, VA. As with Vanguard America, Patriot Front also promotes the Zionist Occupied Government conspiracy theory, which reflects the commonly held white supremacist belief that the US Government is controlled by Jews.

Patriot Front's founder and current leader, Thomas Rousseau, led Vanguard America members during the 2017 Unite the Right rally including (b)(6); (b)(7)(C)

(b)(6); (b)(7)(C) who fatally struck a woman when he ran his vehicle into a crowd of demonstrators. The split from Vanguard America occurred amidst a movement-wide debate over the effectiveness of public demonstrations and the issue of optics in the wake of Unite the Right, which resulted in widespread condemnation from the mainstream public. Patriot Front desired to "tone down" the overtly white supremacist elements of the Unite the Right rally in order to appeal to a more mainstream audience. Despite the desired public image, Patriot Front program materials (such as their manifesto) explicitly call for the formation of a white ethno-state and the removal of non-white, non-European people from America.

Activities

Patriot Front's typical activities, such as putting up posters, distributing flyers, hanging banners from public structures (e.g., bridges), or organizing demonstrations, have been seen in at least 37 states. Members have been known to hand out flyers at former President Trump's rallies. One flyer distribution received media coverage on October 27, 2018, in Murphysboro, IL, when President Trump condemned the shooting at a Pittsburgh, PA, synagogue. The message within the flyers from that day discussed "foreign invaders and global elite taking over the country and how Americans need to reclaim the country."



Patriot Front demonstrations often have a dramatic flair, through the use of a combination of patriotic imagery and attention-grabbing slogans, such as "Reclaim America," and "Strong Families Make Strong Nations."



To date, there has been no evidence Patriot Front members participated in the January 6 US Capitol Building breach.

On January 29, 2021, approximately 15-25 members of Patriot Front held a march in Washington, DC, from the Lincoln Memorial to the US Capitol Building. Those marching wore similar clothing—khakis, matching dark blue jackets with flag patches on the left sleeve, hats, white face coverings with dark sunglasses—and all carried various modified versions of the American flag with the Patriot Front logo. The group protested against "state cancellations of pro-life rallies" and "in support of the nation's right to life." This demonstration was most likely an attempt to gain support from, or appear in solidarity with, the annual March for Life rally.

The group's top-down discipline and brand consistency have found success while some peer groups have struggled to maintain relevance. The fallout from the 2017 Unite the Right rally left many white nationalist groups voiceless in their communities. Patriot Front, has managed to rehabilitate the explicitly white nationalist agenda of Vanguard America with a foothold on major social media platforms with appeal to a nationwide membership. Patriot Front hopes to garner more support and make the movement appear as less threatening as well as more accessible to those who may harbor sympathies. By keeping a closer hold on the activity of its members and avoiding violent confrontations, Patriot Front intends to distance itself from the media image of a white supremacist group.

Oath Keepers



Background

The Oath Keepers is an American right-wing militia organization formed in 2009 by a US Army veteran. The organization is known to recruit current and former law enforcement, first responders, and military personnel. Members claim they will "defend the Constitution from all enemies, foreign and domestic." The organization maintains numerous chapters in multiple states and largely positions itself as pro-law enforcement.

Some Oath Keepers have disseminated conspiracy theories alleging a tyrannical US government, attempting to establish a global world order, will deny American citizens their Constitutional rights. The deprivation of these rights, according to some supporters, will result in the confiscation of firearms, use of warrantless searches, and the unjust imprisonment of American people. In reaffirmation of their oath to the Constitution, the group has codified these principles in a ten-point document titled, "Declaration of Orders We Will Not Obey."

Activities

The Oath Keepers are of record with the USSS since 2014. Members have attended former President Trump's rallies and 2nd Amendment demonstrations throughout the US. The organization has a history of soliciting volunteers prior to these events in order to provide security and protection services from "leftist extremists." They have previously worked with local groups such as Three Percenters and motorcycle clubs.

The Oath Keepers gained widespread media

attention after a number of incidents in which armed members, sometimes also in paramilitary garb, patrolled an area after a high-profile incident. The organization stated these actions were taken to support police or because they believed local government was not doing enough.

- During civil unrest following a Ferguson, MO, grand jury decision not to indict an officer in the fatal shooting of a black man in 2014, Oath Keepers patrolled the streets and kept watch from rooftops.
- In 2016, the Oath Keepers offered to liaise between armed demonstrators occupying the Malheur National Wildlife Refuge in Princeton, OR, and the federal authorities.
- In the aftermath of the 2018 Stoneman Douglas High School mass shooting, the Oath Keepers issued a call to action for armed patrols at schools nationwide.

In 2019, the Oath Keepers released a statement that the group would not be participating in the August "End Domestic Terrorism" rally in Portland, OR, because not enough was done to exclude white supremacists.

On several occasions in 2019 and 2020, Oath Keepers contacted the USSS to announce their intent to attend President Trump rallies in Sunrise, FL, Fayetteville, NC, and Jacksonville, FL, for the purpose of providing protection to the president's supporters. They also indicated they would carry concealed weapons where permitted by law.

Leading up to the US Capitol Building breach, the Oath Keepers promoted the January 6, 2021, "Stop the Steal" rally as a last-ditch effort to reverse the election in favor of President Trump. On January 4, the Oath Keepers website called for support and stated, "We have worked side-by-side with many other patriot groups and veterans. If you are a team leader of a group that will be in DC please email us." Many Oath Keepers participated in the January 6 US Capitol Building breach and some were arrested, including three chapter leaders who were indicted on conspiracy charges. The indictment claimed the breach had been planned weeks in advance and recruiting via social media had begun as early as November 2020. Local Oath Keepers leaders targeted January 6, the date of the Electoral College

certification, as a critical time to show support for President Trump. The leader of the Ohio State Regulars, an Oath Keeper group, allegedly texted a recruit, "Biden may still yet be our President. If he is, our way of life as we know it is over. Our Republic would be over. Then it is our duty as Americans to fight, kill and die for our rights."

An FBI indictment revealed Oath Keepers members operated as a group in order to breach the US Capitol Building and kept in touch using a walkie-talkie app called Zello. Once inside, Oath Keepers are said to have received information on the location of Members of Congress from Facebook messages that read, "All members are in the tunnels... seal them in" and "Go through back house chamber doors facing N left down hallway down steps." The indictment claimed Oath Keepers moved in an organized fashion as they moved through the US Capitol Building. Captured text of Oath Keepers communication detailed their belief they were executing a citizen's arrest on the assembly and believed to have probable cause for acts of treason and election fraud.

In addition to conspiracy charges against the US, the indictment listed charges of obstructing an official proceeding, destroying government property, and entering restricted grounds.

Outlook

The Oath Keepers are part of a militia movement within the US that believes the federal government is denying American citizens their Constitutional rights

After the US Capitol Building breach, several Oath Keepers chapters have announced they no longer support the national organization. For example, the Columbus County, NC, Oath Keepers decided to distance themselves from the national organization after it was revealed approximately 40 members had traveled via charter bus to Washington, DC, on January 6. Their leader, Doug Smith later told the Columbus County (NC) News his followers were "horrified" by what happened at the US Capitol Building and had gone to Washington, DC, only to support President Trump. The Pennsylvania Oath Keepers (PAOK) have a banner displayed on their website stating, "PAOK is NOT affiliated with the National organization Oath Keepers." PAOK notified website visitors that due to censorship practices, their Facebook and Instagram pages have been removed.

A National Terrorism Advisory issued by DHS on January 27 judged domestic violent extremists may feel emboldened following the January 6 US Capitol Building breach to target elected officials and government facilities

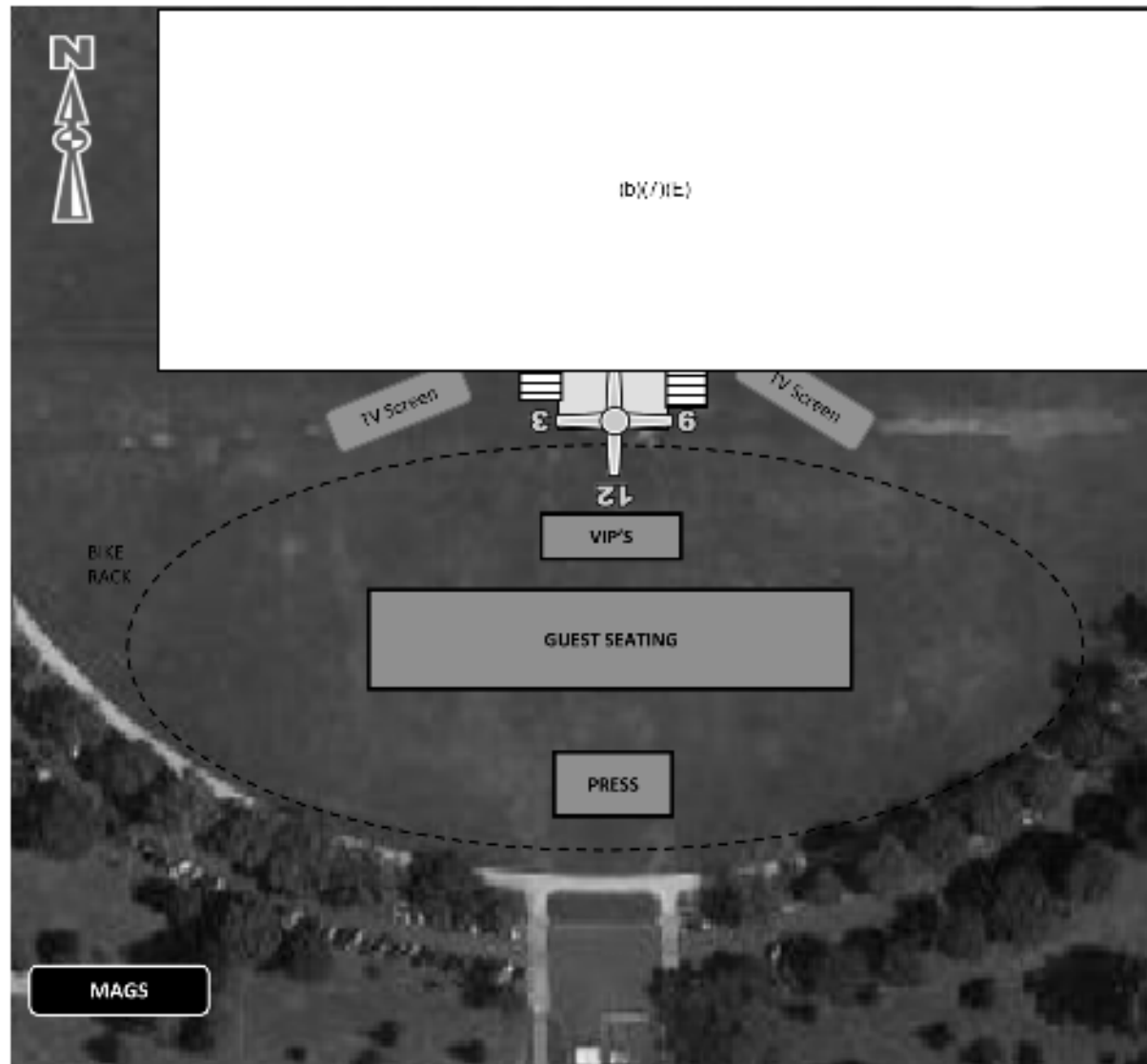


SITE DIAGRAM

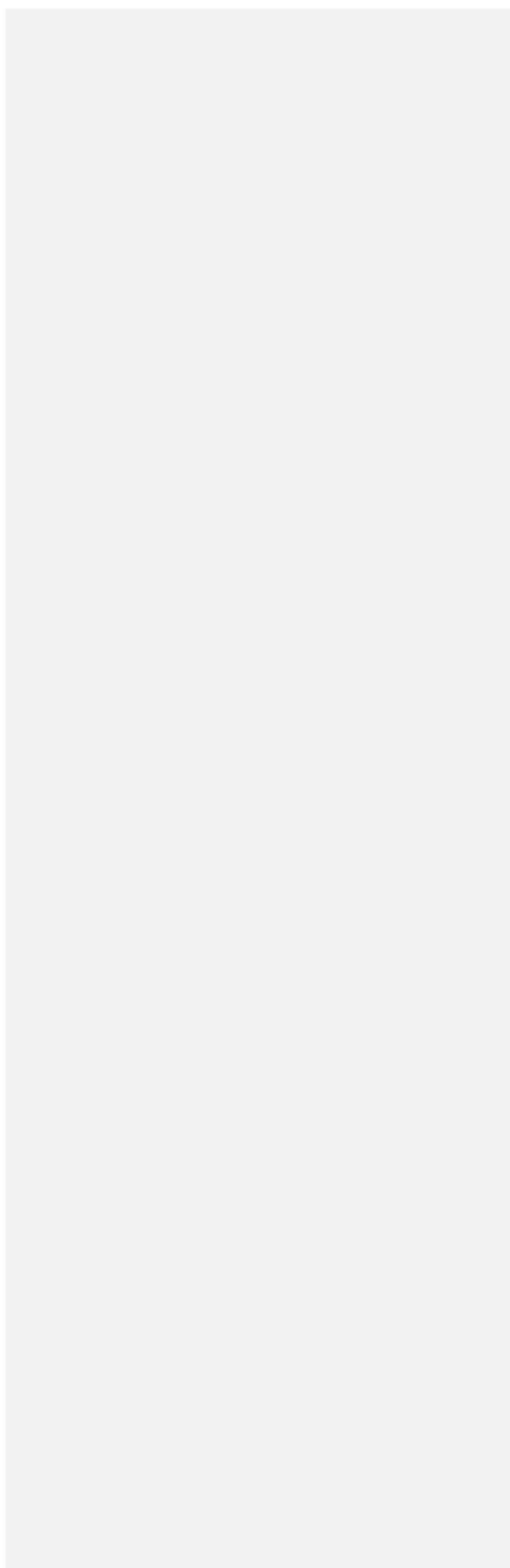

1. What is an NSSE? Event vs. Incident Response (to include civil disturbance)
 - NSSE (PD-22) vs. National Response Framework (ESF 13)
An NSSE is an event of national or international significance deemed by the United States Department of Homeland Security (DHS) to be a potential target for terrorism or other criminal activity. These events usually require months of planning and coordination to ensure the safety and security of those participating in or otherwise attending the event and is typically limited to specific event sites for a specific period. An Incident Response, to include civil disturbance, requires credible intelligence beforehand to plan and respond to a specific incident or occurrence. If no intelligence is gathered ahead of time, the response to an incident is reactionary. The time frame is unscheduled and unspecified.

2. Who makes the request for assistance, who do they request it from and how is it granted?
 - Process for requesting an NSSE designation:
 - 1) Request from the governor of the host state
 - 2) Questionnaire completed by host state
 - 3) NSSE Working Group review of questionnaire
 - 4) If needed, a site walk-thru will be conducted by the Working Group.
 - 5) Working Group recommendation to the DHS Secretary
 - 6) Designation determination by the DHS Secretary
 - Process for requesting assistance within the confines of the NSSE:
 - Any incident that requires additional manpower for other assets will be requested through the MAAC and implemented accordingly
3. What happens if POTUS decides to interrupt or prevent the Inauguration to proceed?
 - The Secret Service is in charge of protecting the Office of the President of the United States. Additionally, The Secret Service is charged with the successful security operation of all NSSE's. Should civil unrest be anticipated in any scenario, we will plan to de-conflict with our all of our law enforcement partners any independent movements of POTUS and his family with inaugural activities.
4. What happens if POTUS supporters try to interrupt or prevent the Inauguration?
 - The USSS developed and will implement a security plan around the US Capitol in consultation with its core partners: the Joint Congressional Committee on Inaugural Ceremonies (JCCIC), the United States Capital Police (USCP), the Presidential Inaugural Committee (PIC), and Joint Force Headquarters – National Capital Region (JFHQ-NCR). Access to the vicinity of the U.S. Capital is by invitation only. USSS, USCP, USPP, MPD and the National Guard will enforce restricted areas in the vicinity of the US Capitol to prevent public access.

- However, the NPS has designated certain areas in close proximity of the White House as public viewing areas. The USSS will allow access into these areas after the public has undergone appropriate security screening.

If individuals or groups decide to act unlawfully, plans have been put in place to efficiently and safely address them. The U.S. Secret Service does not prohibit the presence of signs or props based on their content – only those items made of materials or of a size that could be used in a potentially threatening or harmful manner.

9. How can we change the designation and duration of the NSSE, so we can provide additional coverage (resources)?

○ Process to request is:

1. Request from the governor of the host state
2. Questionnaire completed by host state
3. NSSE Working Group review of questionnaire
4. If needed, a site walk-thru will be conducted by the Working Group.
5. Working Group recommendation to the DHS Secretary
6. Designation determination by the DHS Secretary

○ (Per Legal) Pursuant to the Secretary's 2018 memo, the designated event is the Inauguration. The designation allows the event's Executive Steering Committee to determine which venues and activities associated with that event are covered by the designation. This flexibility allows the local Executive Steering Committee to evaluate which events should be included in NSSE security operations without going back to the Secretary for a specific activity. Typically, this authority is used to cover an evening welcome reception the day before the first day of a political convention or which Inaugural ball will be covered. DHS would need to determine the contours of this flexibility.

10. How many non-DC Law Enforcement are supporting the Inauguration?

The Secret Service has successfully implemented security across five previous Inaugurations on the Mall. The Secret Service has coordinated with the US Park Police and other entities to ensure the security of all sites.

- The U.S. Secret Service in coordination with its core partners from the Joint Congressional Committee on Inaugural Ceremonies (JCCIC), the Joint Task Force – National Capitol Region (JTF-NCR), and the US Capitol Police Inaugural Task Force (ITF) have contingency plans in place for weather and unforeseeable events impacting plans for swearing in at the US Capitol.

14. How will the Global Non-Scalable Fencing be secured by personnel?

- What prevents someone from climbing over the fence?
 - The global anti-scale fencing is constructed of steel with small openings in the mesh that make it very difficult to gain a strong grip with fingertips to scale. The heavy-duty nature of this fence when interlocked with other panels also makes the fence extremely difficult to knock down. All fencing erected at sites will be posted by law enforcement or military personnel to ensure the integrity of the fence and prevent civilians from scaling. Due to the construction and design, any attempt to scale the fence will cause a delay which will allow for additional LE personnel to respond in order to prevent an incursion.

15. What are the countermeasures for Air Space attacks i.e. drones?

- FAA will be enforcing enhanced flight restrictions during events on 19-21 Jan
- As part of the lead planning agency for NSSEs, the U.S. Secret Service's Airspace Security Branch (ASB) has the responsibility for developing, coordinating, and implementing an airspace security plan. It leverages partnerships obtained from coordinating and implementing airspace security plans for sites visited by the President and Vice

President of the United States, and other designated USSS protectees to assist in securing all attendees and the residents of National Capital Region.

- The ASB will coordinate airspace security with the Federal Aviation Administration (FAA), Transportation Security Administration (TSA), DHS, and the Department of Defense's North American Aerospace Defense Command (NORAD).

16. What are we doing to ensure that a device(s) are not being placed in and around the U.S. Capitol?

17. What do we anticipate the impact of the Impeachment Process on the Inauguration?

- How long would it take to get more personnel to bolster CDU staffing?
 - NSSE planning for the Inauguration requires resource allocation measures to be examined, meaning that for any contingency there are pre-positioned security forces, stand-by security forces, and reserve security forces. A Multi-Agency Coordinating Center will be established to communicate needs quickly and efficiently between law enforcement partners. Law enforcement partners have areas of responsibility based on their jurisdictions and will request additional resources as they deem appropriate to any events. At least one representative from each agency is located in the MACC to communicate those needs amongst agencies.

18. Will the parade/walk from the Capitol to the White House be cancelled this year due to COVID-19 safety protocols? Has a decision been made to provide limited access to public viewing areas during the Inauguration?

- Presidential Inaugural Committee (PIC) has announced publicly that the parade / walk will not happen as historically seen. Following the traditional Pass and Review of military units on the East Front of the U.S. Capitol, the parade this year will consist of a ceremonial Presidential Escort from 15th ST, NW to the White House. Remaining parade components will consist of a virtual / made for television parade across the country (see PIC press release dated 01/03/21)

19. Does the Secret Service have enough PPE, access to COVID-19 testing, and other precautionary measures to mitigate the further spread of COVID-19 among its agents and officers in preparation for the Inauguration?

- Yes, all USSS personnel have received an adequate distribution of appropriate PPE as part of the COVID-19 response. USSS personnel will receive additional PPE as necessary prior to beginning inaugural security operations. In addition, the USSS has a robust COVID-19 testing plan which will be implemented in close consultation with the Presidential Inaugural Committee and the Joint Congressional Committee on Inaugural Ceremonies (JCCIC).

20. Understanding there were Secret Service personnel at the Capitol recently, have any USSS officers and/or agents tested positive and/or are in quarantine as a result of the events that transpired Wednesday, January 6th?
- Our personnel wear PPE and practice social distancing when possible. For privacy and operational security reasons, the Secret Service is not releasing how many of its employees have tested positive for COVID-19, nor how many of its employees were, or currently are, quarantined.
21. Due to the recent spike with COVID-19, will the Secret Service have enough personnel available to ensure the security of the January 20 inauguration of President-elect Biden?
- Yes
22. What additional resources can Congress provide that would assist in the planning, coordinating, or equipment that may be necessary to ensure a safe transfer of power on January 20th?
23. What role with DOD/National Guard play during the NSSE on January 20th?
- The District of Columbia National Guard is a vital partner in NSSE planning, and is in continuous engagement with the USSS regarding the operational security plan. The National Guard will play a vital role in the successful implementation of the NSSE security plan.
24. Will the Secret Service be securing the entire route from the U.S. Capitol to the White House? Will President-Elect Biden be walking along the parade route? How many guests/public does the Secret Service anticipate will attend the Inauguration?
- The Secret Service is designated as the lead agency for security operations at the Inauguration and will provide a secure zone of protection from the U.S. Capitol and proceeding to the White House. Any general public "attending" Inaugural events would be at designated NPS public viewing areas within sight and sound from Inaugural venues.
25. Is the USSS getting any indication from the Mayor's Office that Washington, D.C. be on a full day curfew and only essential workers and guests of the Inauguration will be authorized in DC on January 20th?
- At this time it is unknown if the DC Mayor's Office will institute a curfew for general public on Inauguration day.
26. Does the DNC plan to have any galas or other events in the evening on January 20th?
- See attached COVID-19 press release concerning events on 01/19/21 at the Reflecting pool. Events on the evening of 01/20/21 are expected to be made for television / virtual in nature.
27. If a similar size crowd showed up at the U.S. Capitol/White House, what plans do the USSS have in place to manage the crowd?

- o The USSS developed and will implement a security plan around the US Capitol in consultation with its core partners: the Joint Congressional Committee on Inaugural Ceremonies (JCCIC), the United States Capital Police (USCP), the Presidential Inaugural Committee (PIC), and Joint Force Headquarters – National Capital Region (JFHQ-NCR). Access to the vicinity of the U.S. Capital is by invitation only. USSS, USCP, USPP, MPD and the National Guard will enforce restricted areas in the vicinity of the US Capitol to prevent public access.
 - o The USSS developed and will implement a security plan around the White House in consultation with its core partners: the National Park Service (NPS) and the PIC, which will effectively restrict all public access to the vicinity of the White House. USSS, USPP, and MPD will enforce restricted areas in the vicinity of the White House. However, the NPS has designated certain areas in the vicinity of the White House as public viewing areas. The USSS will allow access into these areas after the public has undergone appropriate security screening.
28. Following the 'March for Trump' Rally that was held on the Ellipse on Wednesday, what steps did the USSS take to pass along pertinent information to the USCP related to the size, anticipated civil disturbance, and general disposition of the crowd?
- o Unknown at this time.
29. What obstacles prevented your organization from quickly responding to the terrorist attack on the U.S. Capitol? Access to the building (hard U.S. Capitol passes), poor radio communication to effectively coordinate where assets were needed, etc.
- o Except when implementing a security plan during a NSSE (when the USSS has additional responsibilities in coordination with the FBI), the USSS primary response to terrorist attacks is the safety and security of its protectees. During the incident at the U.S. Capitol on 01/06/21, the USSS successfully ensured the safety and security of its protectees at all times.
30. Does the USSS conduct after action drills following critical incidents at the White House (ex: the anti-police brutality protests at the White House in June 2020) and share this information with its personnel?

- o

31. How has the USSS embraced emerging technologies in the less-than-lethal weapons acquisition? Do your officers and agents receive training on these new platforms? How has the USSS embraced emerging technologies in facial recognition software and deployed in at protective sites?
- USSS agents and officers carry less lethal weapons and are instructed on their appropriate use as part of their training and in accordance with applicable laws regarding the use of force.
32. Will the entire White House Complex, parade route, and Capitol be surrounded by the 7' anti-scale steel fencing? If so, when will the fencing be installed? Removed?
- The USSS has already begun implementation of certain enhanced security measures around the White House Complex and the US Capitol. This will continue to occur in the coming days as the Inauguration approaches until a full-scale NSSE security posture is reached prior to the morning of Inauguration.
33. Has DHS provided adequate personnel and equipment to assist the USSS in coordinating and managing the security operations for the Inauguration?
- Yes
34. What type of mutual aid agreements does the USSS have with other law enforcement agencies in the National Capitol Region?
- As it relates to the Inauguration NSSE: The USSS is the lead federal agency responsible for planning and implementing security measures. With this legally mandated role, the USSS has the authority to obtain assistance from any federal agency to provide appropriate security assets and capabilities to secure the NSSE. During the NSSE planning cycle for the Inauguration, the USSS has worked closely with its state and local law enforcement agencies to ensure enhanced security measures, to include appropriate numbers of law enforcement and public safety personnel are deployed for the Inauguration NSSE.
35. As we know, law enforcement in general is defensive and reactive in nature. In the last few decades the shortcomings of the ability of the law enforcement community to effectively communicate and coordinate amongst its fellow partners has been brought to light. What operational changes has the USSS made in the area of protection to address the above issue?
- USSS has incorporated many recommendations from the Protective Mission Panel and have subsequently increased personnel training hours with UD and SA.
 - As it pertains to the Inauguration NSSE: The planning framework itself is proactive in nature. The USSS by its core mission and nature is well-suited for proactive planning in security measures. Planning for the 2021 Inauguration began over a year ago, with the formation of an Executive Steering Committee of law enforcement partners from around the National Capitol region, and the formation of sub-committees to manage the necessary requirements and assets.

36. Concerning National Special Security Events (NSSE) managed by the USSS, what components or aspects of these security plans continue to be problematic for the USSS? How has the agency responded to these challenges and what steps have been taken in recent years to strengthen its posture at a NSSE?
- As it pertains to the Inauguration NSSE: The planning framework itself is proactive in nature. The USSS by its core mission and nature is well-suited for proactive planning in security measures. Planning for the 2021 Inauguration began over a year ago, with the formation of an Executive Steering Committee of law enforcement partners from around the National Capitol region, and the formation of sub-committees to manage the necessary requirements and assets.
 - The USSS has managed several NSSEs over the past year to great success, using this same model. An example of these are the Democratic and Republican National Conventions. In addition, outside the NSSE model, the USSS implements protective planning for events as a routine with its law enforcement partners for other events such as the Presidential and Vice Presidential debates and the election night events in Washington DC and Wilmington, DE.
37. Recent failures in the security planning of federal buildings in the NCR (White House in 2014 and the U.S. Capitol in 2021), these fortified buildings long believed to be impregnable have seriously challenged the public's confidence of law enforcement to safeguard these American institutions. What lessons learned have been identified from these security breaches? What adjustments in particular has the USSS made as preventive measures? Are there any measures that have not been implemented due to fiscal or manpower constraints?
- The USSS took proactive approaches to reviewing the security breaches it experienced in 2014. These measures include enhanced security procedures and additional training of personnel to address identified vulnerabilities. The USSS routinely reviews its security procedures to ensure proper procedures are followed and security measures are adjusted to address developing threats.
38. Why wasn't the Vice President evacuated from the U.S. Capitol upon learning about the anarchist activity at the U.S. Capitol? Did his continued presence there require additional USCP resources that could have been better used protect the U.S Capitol grounds and personnel?
- During the incident at the U.S. Capitol on 01/06/21, the USSS successfully ensured the safety and security of its protectees at all times and worked with its Capitol Police partners to ensure not only the Vice President's safety, but the safety of the congressional members and staff present.
39. Will you allocate more resources to groups comprised with people of color and allow groups of "patriots" to gather unobserved?
- The U.S. Secret Service, and its federal, state, local partners without question, respects the right of the public to demonstrate and voice their views. We make no distinction on the purpose, message or intent of any particular group. If individuals or groups decide to act unlawfully, plans have been put in place to efficiently and safely address them. The U.S. Secret Service does not prohibit the presence of signs or props based on their content – only

those items made of materials or of a size that could be used in a potentially threatening or harmful manner.

40. President Trump may not attend the inaugural ceremonies - either by his own choice, as a result of the invocation of Section 4 of the 25th Amendment (declaring the President unfit to perform his duties), or as a result of impeachment proceedings. How would each of these situations affect planning and resource allocation for the event?
- o The USSS has developed a security plan capable of responding to all contingencies of civil unrest that may occur. Independent movements of President Trump will continue to be coordinated with federal, state, and local law enforcement regardless of his location on Inauguration Day.
41. If a situation arises where security forces in place are becoming overwhelmed or are in danger of being overrun, what is the plan for bringing in reinforcements? Have those agencies/units been identified? Who will make the request/give the order? Where will they be located? How will they relocate to where they are needed? What will their response time be?
- o NSSE planning for the Inauguration requires resource allocation measures to be examined, meaning that for any contingency there are pre-positioned security forces, stand-by security forces, and reserve security forces. A Multi-Agency Coordinating Center will be established to communicate needs quickly and efficiently between law enforcement partners. Law enforcement partners have areas of responsibility based on their jurisdictions and will request additional resources as they deem appropriate to any events. At least one representative from each agency is located in the MACC to communicate those needs amongst agencies.
42. Due to the perimeter failure around the U.S. Capitol, demonstrators were able to gain access into the depths of both chambers of Congress. Those Capitol Police officers assigned to interior portions of the building, especially those posted near the House and Senate Chambers, faced an overwhelming, non-compliant, and in some cases violent, mob of demonstrators. As we all know, one person tragically lost their life as a result of an officer discharging their firearm. The facts surrounding this incident are not yet known, so I don't want to speculate on the officer's justification for the use of deadly force. As an agency, explain how Secret Service personnel are trained to respond to a non-compliant mob who have circumvented security, and gained access to a protected venue? What is the USSS use of force policy?
- o USSS personnel are trained to use reasonable force in light of the totality of circumstances, consistent with constitutional norms.
43. I know that Use of Force policies vary from department to department and agency to agency. There have been recommendations for a "national" Use of Force policy that would require adoption by state and local agencies as a condition of certain federal funding. Do you support a "national" use of force policy? In your opinion, what would be the key pillars of any such policy?

- o The USSS is subject to the larger DHS use of force policy, which applies to the actions of all LEOs across the spectrum of departmental functions.

45. Has the USSS coordinated or plan to coordinate with Capitol Police on an after action report to discuss "lessons learned"? Who will be the lead agency for security when President-Elect Biden is at the Capitol?
- o The USSS has a great working relationship with the US Capitol Police and our personnel will be coordinating our security plan and lessons learned throughout the advance planning process. As an NSSE, the USSS is the designated lead agency for the design and implementation of security operations. The USSS will continue to coordinate security for the Inauguration with many federal state and local partners.
46. Will the Secret Service allow people to "peacefully" assemble near the U.S. Capitol or White House?
- o The U.S. Secret Service, and its federal, state, local partners without question, respects the right of the public to demonstrate and voice their views. We make no distinction on the purpose, message or intent of any particular group. If individuals or groups decide to act unlawfully, plans have been put in place to efficiently and safely address them. The U.S. Secret Service does not prohibit the presence of signs or props based on their content – only those items made of materials or of a size that could be used in a potentially threatening or harmful manner.

47. What adjustments have you made to the planning of the Inauguration with regards to the events that transpired at the U.S. Capitol on January 6th?
- USSS has assisted the United States Capitol Police (USCP) in implementing various additional security measures around the U.S. Capitol immediately following the events of 01/06/21. The USSS and USCP continue to collaborate on methods to ensure a robust security posture around the U.S. Capitol during the Inauguration.
48. This past summer there was largely peaceful protests in light of the George Floyd murder and other Black Lives Matter lead protests on the grounds of the White House, can you explain why there was such a large number of police at the summer protests but such a small number of Capitol Police protecting the U.S. Capitol and the Vice President on January 6th?
- The Secret Service does not coordinate security for the Capitol, outside of an NSSE. On 1/6/21, the presence of the Vice President at the Capitol required the USSS to coordinate the movements of the Vice President with the Capitol Police to ensure he remained safe at all times.
49. Knowing that your agency will engage peaceful protestors to allow the current President the ability to make a political statement in front of St. John's Church, how can we have confidence that your agency will keep domestic terrorists away from the Capitol and White House?
- The USSS is responsible for ensuring a secure environment for any location its protectees choose to visit. This includes the coordination and support of DHS, and other federal, state, and local law enforcement partners.

Responsible Directorate – SII

50. Does the Secret Service recognize Q Anon as a domestic terrorist group? Did the USSS have any intelligence that groups of Trump Supporters were going to breach the U.S. Capitol?
- The Secret Service is not part of the intelligence community and does not classify any group or groups as domestic terrorist. It is unknown at this time if USSS provided information to Capitol Police about the large groups of public heading toward the U.S. Capitol.
51. Will any permits be granted to demonstrators and if so where will they be allowed to demonstrate?
- That National Park Service issues permits relative to this event. I would refer you to the NPS for the most accurate information relative to demonstration permits.
52. It has been reported that social media played a crucial part in helping to organize, plan and execute the terrorist attack on the U.S. Capitol last week. What steps did the USSS take to monitor and pass along cyber-intelligence/information to your law enforcement partners?

53. How are you tracking potential demonstration activity or plans for civil disturbance on open source, public, or non-public social media platforms?

- o Our Protective Intelligence Division is able to provide our operational personnel information regarding planned civil disturbances, and we have protocols in place in an effort to anticipate the number and intention of demonstrators in connection with inaugural events.

- o (DPD Response) USSS Response is 20K requested permit and 25K screened and 10K/15K additional public outside. [REDACTED] (b)(5)

- o Acting Chief Capitol Police stated that there was 20K-30K on Capitol ground and approximately 1K inside Capitol.

2. How many public does the USSS anticipate to attend the DC Inauguration?

- o Not sure if this information is already released to the public so requesting to ensure that this information can be disseminated for this level of briefing.
 - o (DPD answer) Estimates of attendees invited to the Inaugural ceremonies at the US Capitol are approximately 2,000 mostly consisting of elected officials, high level government officials, spouses, immediate family and guests. There are no other invited guests to Inaugural events

3. With various agencies participating in the inauguration security planning, what are the rule of engagement?

(Please address Use of Force, command structure, arrest authority by non-USSS, what happens regarding an arrest or incident)

- o (OPO Response) NSSE planning for the Inauguration requires resource allocation measures to be examined, meaning that for any contingency there are pre-positioned security forces, stand-by security forces, and reserve security forces. A Multi-Agency Coordinating Center will be established to communicate needs quickly and efficiently between law enforcement partners. Law enforcement partners have areas of responsibility based on their jurisdictions and will request additional resources as they deem appropriate to any events. At least one representative from each agency is located in the MACC to communicate those needs amongst agencies. USSS personnel must use a level of force that is reasonable based on the totality of the circumstances.

- (Legal's Response) The inauguration security plan contains no overarching rules of engagement that dictates when force is or is not authorized. However, each participating agency must adhere to its own use of force policy.
 - The Secret Service use of force policy authorizes agency personnel to use force that is objectively reasonable under the circumstances to accomplish their law enforcement mission. Agency law enforcement personnel may only use deadly force against an individual who they reasonably believe poses a significant threat of death or serious physical harm to others. While each agency participating in the inauguration security plan has its own use of force policy, they all contain similar rules regarding when lethal and non-lethal force is authorized.
4. Will the National Guard participating in the Inauguration security plan be armed?
- (OPO Response) Director Murray and General Millie are continuing ongoing conversations regarding National Guard baring arms.
 - OPO is requesting all National Guard personnel are Unarmed and Civil Disturbance Trained/Equipped
 - (Legal's Response) Noting that the original RFA to DoD did not include that requirement. Originally we asked for a quick response unit for CDU purposes, among the many units/functions requested.

Background

In 2018, The Secretary of Homeland Security designated the Presidential Inauguration as a recurring National Special Security Event (NSSE), thereby authorizing the U.S. Secret Service to assume its mandated role as the lead agency for the design and implementation of the operational security plan. The 2021 Presidential Inauguration will be held on January 20, 2021.

The Department of Homeland Security (DHS) is responsible for incident management and its component, the Federal Emergency Management Agency (FEMA), is responsible for emergency consequence management and recovery / restoration operations. The Federal Bureau of Investigation (FBI) is the lead for crisis incident investigation and management as well as intelligence gathering and counter-terrorism operations.

During the formation of the Secret Service's overall security plan, each participating law enforcement / public safety / security organization is tasked based on their jurisdiction and subject matter expertise. This is accomplished through the formation of subcommittees, staffed by multi-jurisdictional subject matter experts (SMEs), with the collective responsibility to plan for every possible security matter. These subcommittees are inclusive of the following examples: Airspace Security, Crisis Management, Consequence Management, Interagency Communications, Fire/Life Safety – HAZMAT, Tactical Response, and Crowd Management. Each subcommittee is chaired or co-chaired by a Secret Service agent and staffed by the appropriate federal, state, or local law enforcement/public safety agency.

Messages

- The 59th Presidential Inauguration, to be held on Wednesday, January 20, 2021, was designated a National Special Security Event (NSSE) by the Secretary of the Department of Homeland Security (DHS) on September 24, 2018.
- The designation of NSSE status triggers the mandated role of the U.S. Secret Service to assume the role of the **lead agency** responsible for the design and implementation of the operational security plan.
- The 2021 Inauguration will be the **67th NSSE**.
- The Federal Bureau of Investigation (FBI) is the lead for crisis incident investigation and management as well as intelligence gathering and counter-terrorism operations. The

Federal Emergency Management Agency (FEMA), is responsible for emergency consequence management and recovery / restoration operations.

- The U. S. Secret Service carries out its responsibilities by relying on a core strategy: **interagency partnerships** at every level with all involved law enforcement, public safety and military entities.
 - In addition to FBI and FEMA our primary partners for creating the security plan for this Inauguration are the Metropolitan Police Department, the U.S. Capitol Police, the U.S. Park Police and the Joint Task Force – National Capital Region (JTF-NCR).
- In preparing for an event as significant as the Inauguration, the U. S. Secret Service employs a unified command model – an executive network comprised of representatives from those agencies with primary jurisdiction for the event (e.g. the Executive Steering Committee - ESC).
- Our goal is to develop and implement, with the numerous participating agencies, a **seamless** security plan that will create a safe and secure environment for our protectees, other dignitaries, event participants and the general public.
- During the formation of the U. S. Secret Service's overall security plan, each participating law enforcement / public safety / security organization is tasked based on their jurisdiction and subject matter expertise.
- This is done through the formation of subcommittees staffed by multi-jurisdictional subject matter experts (SMEs). There are currently 28 separate subcommittees whose collective responsibility is to plan for every possible security matter, inclusive of community impact.
 - The following are some of the subcommittees responsible for the safety and security of the 2021 Inauguration: Airspace Security; Crowd Management Explosive Device Response; Fire / Life Safety / HAZMAT; Maritime Security; Parade Route; Private Sector / Community Outreach; Transportation/Traffic; Venue Security; VIP / Dignitary Protection.
- Although the U.S. Secret Service **cannot discuss the means, methods**, specific resources, or numbers we utilize to carry out our protective responsibilities, we can say there is a tremendous amount of advance planning and coordination.
- The expertise of each participating law enforcement, public safety, and military agency is critical to the success of the coordinated security plan.

- We train on a continuing basis so that each individual remains prepared to respond to any eventuality.
 - Responses must be immediate, well-coordinated, and effective.
 - A variety of training initiatives are being conducted to ensure such preparation, inclusive of medical emergencies, inter-agency tabletop exercises and field exercises.
- The preparation for any NSSE is a cooperative effort. No one federal, state, or local agency alone can carry out the measures necessary to secure the event.
 - An event of this magnitude can only be secured successfully through intense planning, communication, and training.
 - While an event of this size will cause inconveniences to the city, the U.S. Secret Service, working together with its law enforcement and public safety partners, will make every effort to anticipate and minimize those disruptions.
 - This is specifically prioritized and facilitated through the subcommittee on community impact.

Questions and Answers

COVID-19

Q1. How will this year's 2021 Inauguration be different from ones in the past?

A1. During the 59th Presidential Inauguration public safety and health are a priority for the Secret Service and our federal partners. Although the environment can change when it comes to COVID, the Secret Service always consults CDC guidance to formulate our risk assessment, disease prevention, and protection in public spaces as we make plans for the event.

Q2. How many Special Agents have contracted COVID-19 while serving in a protection role?

A2. For privacy and operational security reasons, the Secret Service is not releasing how many of its employees have tested positive for COVID-19, nor how many of its employees were, or currently are, quarantined.

2021 Election

Q3. Are you prepared to forcibly remove the sitting President if he decides not to leave the White House?

A3. I'm here today to talk about the Secret Service's role in the security of the upcoming Inauguration, which is my area of expertise.

Q4. The Washington Post released information about a changeover in the Secret Service when Biden assumes the Presidency. Is this true? Do you want to add on to the report?

A4. I'm here today to talk about the Secret Service's role in the security of the upcoming Inauguration, which is my area of expertise.

Q5. Have there been any changes issued to the U.S. Secret Service by President-Elect Biden?

A5. As a matter of practice and due to operational security, the agency does not comment on protective operations inclusive of internal decisions on agency assignments.

Security

Q6. How will security be different now that we are in a COVID-19 environment?

A6. The standard for security remains the same. Regardless of environmental factors and challenges, the unified mission is to provide a safe and secure environment for our protectees, other dignitaries, event participants and the general public during an event of national significance.

As is always the case, security during an NSSE is a **layered network of operations, run in tandem with partner entities** with unique specializations for each of their security equities. The Secret Service has ensured that all operations are conducted in compliance with the health recommendations of the CDC as well as the White House Medical Unit and agency medical personnel.

The Inauguration will be no different, and the agency will continue to prioritize the effective execution of the mission in accordance with the most recent health guidance.

As a matter of practice and due to operational security, the agency does not comment on protective operations inclusive of internal decisions on agency assignments.

Q7. How are the U.S. Secret Service and FBI's responsibilities different during the 2021 Inauguration? Who is in charge?

A7. The U.S. Secret Service is the federal agency responsible for the preparation and implementation of operational security planning and partnering with local law enforcement. The FBI is a co-chair throughout the planning and is the federal agency responsible for intelligence, counterterrorism, hostage rescue, Weapons of Mass Destruction/render safe, explosive device management and criminal investigations.

The FBI is involved as part of a larger interagency and law enforcement effort to keep the events of the week and the surrounding community safe; however, the U.S. Secret Service is the lead for overall physical security operations and inter-agency incident management. Our support comes in the form of intelligence sharing, personnel and other assets that respond immediately to address any safety concerns or threats that may arise. The FBI is responsible for investigating any criminal incident related to the event.

Q8. How many law enforcement officers will be used?

A8. For operational security reasons, we do not discuss the cost of security or the numbers of law enforcement or military involved for specific events. A sufficient number of agents, officers, technicians, analysts, and support personnel from all partnering agencies have been agreed upon. Requests for Assistance for personnel from agencies outside those with primary jurisdictions have been requested from Federal, State, and Local jurisdictions through the use of appropriate legal authorities to ensure the proper skill sets are in place to deal with any contingency.

Q9. President-Elect Biden will be traveling via train to the Inauguration. How will you secure the more than 90-miles of track?

A9. The U.S. Secret Service cannot discuss the means, methods, specific resources, or numbers we utilize to carry out our protective responsibilities, we can say there is a tremendous amount of advance planning and coordination involved in any movement of a protectee to ensure seamless security planning and potential response.

Q10. What is a security perimeter?

A10. A security perimeter is a multi-layered buffer surrounding a protected venue or [motorcade/parade] route that is of sufficient size to mitigate a variety of threats. Typically, the perimeter includes law enforcement officers, physical barriers, and checkpoints that are used to screen those who seek access to the event.

Q11. How have you prepared for the anticipated demonstrations?

A11. The U.S. Secret Service, and its federal, state, local partners without question, respects the right of the public to demonstrate and voice their views. We make no distinction on the purpose, message or intent of any particular group. If individuals or groups decide to act unlawfully, plans have been put in place to efficiently and safely address them. The U.S. Secret Service does not prohibit the presence of signs or props based on their content – only those items made of materials or of a size that could be used in a potentially threatening or harmful manner.

Q12. How much does it cost to secure an event like the 2021 Inauguration?

A12. For operational security reasons, we do not discuss the cost of security. What I can tell you is that we will provide enough security and response personnel to provide a safe venue for the 2021 Inauguration.

Q13. How many people do you estimate will be in and around the Washington, DC area during the Inauguration?

A13. Estimates vary with each Inauguration but we are working collaboratively with our partners to make sure the event will be safe and secure for those we protect and the residents of/and visitors to the Nation's Capital.

Q14. What is the security perimeter for the 2021 Inauguration and when will it be released?

A14. A comprehensive security and traffic plan will be developed through federal, state, and local partners and released prior to the start of the Inauguration. The establishment of the perimeter is ever-evolving and is determined in consultation with current intelligence and information from our public safety partners. This traffic plan will include road closures, access locations, and parking restrictions for the areas of Washington D.C. affected by the 2021 Inauguration.

Q15. How will media be credentialed?

A15. The Presidential Inaugural Committee will have the responsibility to credential the media before the 2021 Inauguration. The U.S. Secret Service and its partners are responsible for the security, safety, and access to the event. We will refer you to the Presidential Inaugural Committee for more details on how the media can credential for the event.

Q16. What items are prohibited inside the perimeter? Who determines what is prohibited?

A16. The Secret Service determines the prohibited items list. Any updates to the list will be provided via Twitter: TBD.

Aerosols; ammunition; animals other than service/guide animals; backpacks and bags exceeding size restrictions (Dimension 18"x13"x7"); bicycles; balloons; coolers; drones and other unmanned aircraft systems; explosives; firearms; flammable liquids; glass, thermal, or metal containers; laser pointers; mace/pepper spray; packages; selfie sticks; structures; signs exceeding the size restrictions (20' x 3' x 1/4"); support for signs and placards; toy guns; explosives; recreational motorized mobility devices; weapons of any kind; any other items determined to be potential safety hazards.

The Secret Service does not prohibit the presence of signs based on their content. The only exception pertains to signs containing messages that threaten the life of our protectees in violation of 18 U.S.C. §§ 871 and 879. Agents and Uniformed Division Officers will exclude signs made of or supported by materials that could be used in a threatening. For example, signs such as those made of metal or wood that could be thrown at a protectee.

Q17. Should an incident occur, who is the lead agency in Washington, D.C., to respond and investigate?

A17. The lead agency to investigate will be based on the location and nature of the incident to be investigated. A criminal violation occurring outside the secure perimeter unrelated to the Inauguration would be investigated by the agency of primary jurisdiction, generally the arresting agency. Potential criminal activity associated with the Inauguration could be investigated by any agency, local, state or federal, involved in the security plan based on the location, circumstances of the violation and the most appropriate charge. An act of terrorism or an assault on a protectee of the Secret Service will be investigated by the FBI.

Demonstrations

Q18. How do you define demonstrations and protestors? Have you prepared for both?

A18. The Secret Service respects the right of the public to demonstrate and voice their views. The Secret Service makes no distinction on the purpose, message, or intent of any particular group. If individuals or groups decide to act unlawfully, plans have been put in place to efficiently address them while allowing other members of the public to enjoy the democratic process.

The U.S. Secret Service does not establish Demonstration Areas, Free-Speech Zones, or Public Viewing Areas either inside or outside of any secured areas. We establish restricted and non-restricted areas for the NSSE.

Metropolitan Police Department and their partners will be appropriately prepared to manage demonstrations, allowing groups to express their First Amendment rights safely.

Q19. There are organizations that don't want to see this transition happen, what are you prepared to do if they protest your protectee movements?

A19. While we will not discuss the means and methods associated with our protective operations, we are confident in the comprehensive security plan that we have put together over the past approximate 18 months.

In limited cases when the U.S. Secret Service or local law enforcement has information that a demonstration poses a security risk to a U.S. Secret Service protectee, protected facility, or to public safety, we may initiate or participate in discussions with a demonstration group.

Any such meeting or contact will normally include local law enforcement authorities. If a demonstration group agrees to an approved upon First Amendment demonstration site, it will be the responsibility of the event sponsor or local authorities to enforce the terms of the agreement.

Q20. How many demonstrators/protestors do you estimate will be on hand for the 2021 Presidential Inauguration?

A20. As a matter of policy, we do not provide estimates. We understand the nature of this event and have anticipated protests and/or demonstrators who may be present. We are working collaboratively with our partners to make sure the event will be safe and secure for those we protect and the residents of, and visitors to Washington, D.C. The NSSE designation allows us to use available public safety resources to implement a coordinated security plan. This plan will allow for all groups to peacefully and lawfully express their first amendment rights.

The U.S. Secret Service and our law enforcement partners have long recognized the constitutionally-protected right of the public to demonstrate and voice their views to their elected officials. We make no distinction among the purposes, messages, or intent of particular groups. However, if there are facts or observable actions that would indicate demonstration activity poses a security threat, any individual or group removed from an event may be interviewed by the U.S. Secret Service as part of our routine protective responsibilities.

Airspace

Q21. Who is responsible for air security?

A21. As part of the lead planning agency for NSSEs, the U.S. Secret Service's Airspace Security Branch (ASB) has the responsibility for developing, coordinating, and implementing an airspace security plan. It leverages partnerships obtained from coordinating and implementing airspace security plans for sites visited by the President and Vice President of the United States, and other designated USSS protectees to assist in securing all attendees and the residents of National Capital Region.

The ASB will coordinate airspace security with the Federal Aviation Administration (FAA), Transportation Security Administration (TSA), DHS, and the Department of Defense's North American Aerospace Defense Command (NORAD).

Q22. Who is in charge of the airspace security plan?

A22. In collaboration with the FAA and other federal partners, the U.S. Secret Service works together to establish the airspace security plan for the 2021 Inauguration. As a matter of operational security, we cannot release this information out to the public.

Q23. What is the policy for drone use during the Presidential Inauguration?

A23. During the Presidential Inauguration a "No Drone Zone" will be enacted and strictly enforced. The U.S. Secret Service is working with our partners at the FAA to roll out an aggressive public awareness campaign addressing the operation of drones in and around the U.S. Capitol and the National Mall.

Threats

Q24. What type of threats do you expect?

A24. Numerous agencies at the federal and state level are putting a lot of effort and resources to prevent an attack of any kind, but public safety also heavily depends on help from the public to report suspicious activity. If you see something, say something.

Q25. What specialized units are being deployed for this event?

A25. The Secret Service will have a variety of assets to support the event and that will include investigative and analytical resources; as well as technical capabilities available for any kind of contingency.

Uniformed Division

Q26. What is the role of the Uniformed Division within the Secret Service?

A26. The U.S. Secret Service Uniformed Division's mission is to protect facilities and venues secured for Secret Service protectees. Specifically, is mandated by law to provide physical security for the White House Complex and the Vice President's residence at the Naval Observatory.

UD also provides security for the Treasury Department building and foreign diplomatic missions in Washington, D.C. The Uniformed Division also has specialized teams including Counter Sniper, Emergency Response, K-9, and more.

Q27. What is the role of the Uniformed Division during an Inauguration?

A27. The U.S Secret Service UD will have a vital role in securing a number of venues associated with the 59th Presidential Inauguration. UD will work especially alongside law enforcement and public safety partners on access control issues. This partnerships extend to MPD, Capitol Police, Amtrak Police, US Park Police and others. We also have several specialty units including Magnetometers, K-9, Motors (Motorcycles), Trek (Bicycles), Emergency Response Team (ERT), Counter snipers, all of which serve as specialty units with unique tasks pertinent to NSSE security.

Q28. How many counter snipers does the USSS have and what will they be doing on Inauguration day?

A28. While we don't discuss the specifics of our operational preparations, I can tell you that we have highly trained counter sniper teams that will be working throughout the city during Inauguration.

Recent Violence at the Capitol

Q29. Just days ago, we saw a violent mob storm the Capitol. Are you preparing for something like that to happen at the Inauguration?

A29. For well over a year, the U.S. Secret Service, along with our NSSE partners, has been working tirelessly to anticipate and prepare for all possible contingencies at every level to ensure a safe and secure Inauguration Day.

The inauguration of the President of the United States is a foundational element of our democracy. The safety and security of all those participating in the 59th Presidential Inauguration is of the utmost importance.

Q30. Does the Inauguration present a specific risk or opportunity for any form of civil unrest?

A30. The inauguration of the President of the United States is a foundational element of our democracy. The safety and security of all those participating in the 59th Presidential Inauguration is of the utmost importance and the Secret Service is and has been prepared to execute our no-fail security mission.

The U.S. Secret Service, and its federal, state, local partners without question, respects the right of the public to demonstrate and voice their views. We make no distinction on the purpose, message or intent of any particular group. If individuals or groups decide to act unlawfully, plans have been put in place to efficiently and safely address them.

Q31. How specifically have plans developed or evolved in response to the violence at the Capitol?

A31. Out of concern for operational security, I cannot discuss the specific methods we have prepared and in place. What I can say, is the public can be assured of a layered network of security operations that will ensure a safe and secure 59th Presidential Inauguration.

Dear Acting Secretary Wolf:

Following the unprecedented terrorist attack on the United States Capitol on Wednesday, January 6, 2021, and the continued threat of related violence in the District of Columbia, we are extremely concerned about the upcoming National Special Security Event (NSSE) led by the United States Secret Service. We believe strongly that the 59th Presidential Inauguration on January 20 will require a very different approach than previous inaugurations given the chaos, injury, and death experienced at the United States Capitol during the insurrection. While I will be reaching out to a broad range of local, regional, and federal partners to enhance cooperation among our bodies, I strongly urge the United States Department of Homeland Security to adjust its approach to the Inauguration in several specific ways.

First, the District of Columbia is requesting the Department extend the National Special Security Event period to run from Monday, January 11 to Sunday, January 24, 2021. This is an increase from the current period of January 19 to January 21, 2021, which will allow for better Federal and District government interagency preparation for the Inauguration, given the new threats from insurgent acts of domestic terrorists. Further, the District strongly recommends that you secure the permission of the Congress of the United States to include the Capitol and its grounds in the NSSE perimeter.

Second, the District of Columbia is submitting a request for a pre-disaster declaration under the Robert T. Stafford Act for the Inauguration. This declaration will enhance and expedite direct federal assistance needed to prepare for the Inauguration. My Administration is developing specific requests for direct federal assistance and will work with FEMA to execute those requests upon approval of the declaration.

Third, the District of Columbia urges the Department to coordinate with the Department of Defense and the Department of Justice, the United States Congress, and the United States Supreme Court to establish a security and federal force deployment plan for all federal property, which will ensure the Metropolitan Police Department's (MPD) ability to focus on its local mission in the District's eight wards. Earlier this week, MPD officers acted heroically rushing to back-up the United States

Capitol Police to stop the assault on the United States Capitol. Consistent with established protocols and practices, it is the primary responsibility of the federal government to secure federal property in these situations.


In addition, I ask that the Acting Attorney General at the Department of Justice direct the Federal Bureau of Investigation to provide an intelligence and threat briefing on a daily basis during the period of January 11 – 24, 2021, to the DC Homeland Security and Emergency Management Agency (HSEMA) and MPD and all law enforcement entities operating in the District of Columbia.

Further, I am requesting that the Secretary of the Department of Interior cancel any and all Public Gathering Permits in the District of Columbia and deny any applications for Public Gathering Permits during the period of January 11 – 24, 2021. We have made this request repeatedly since June 2020 because of the COVID-19 pandemic, and this week demonstrated the National Park Service's willingness to approve last minute permits and major adjustments.

The requests outlined herein — if issued swiftly and communicated broadly — are essential to demonstrating our collective resolve in ensuring the Constitutional transition of power and our nation's capital in the days leading up to it. And like with previous inaugurations and NSSEs, the District of Columbia will host a press event for agencies engaged in the NSSE to brief the public on the plan and coordination among our agencies. We look forward to federal participation.

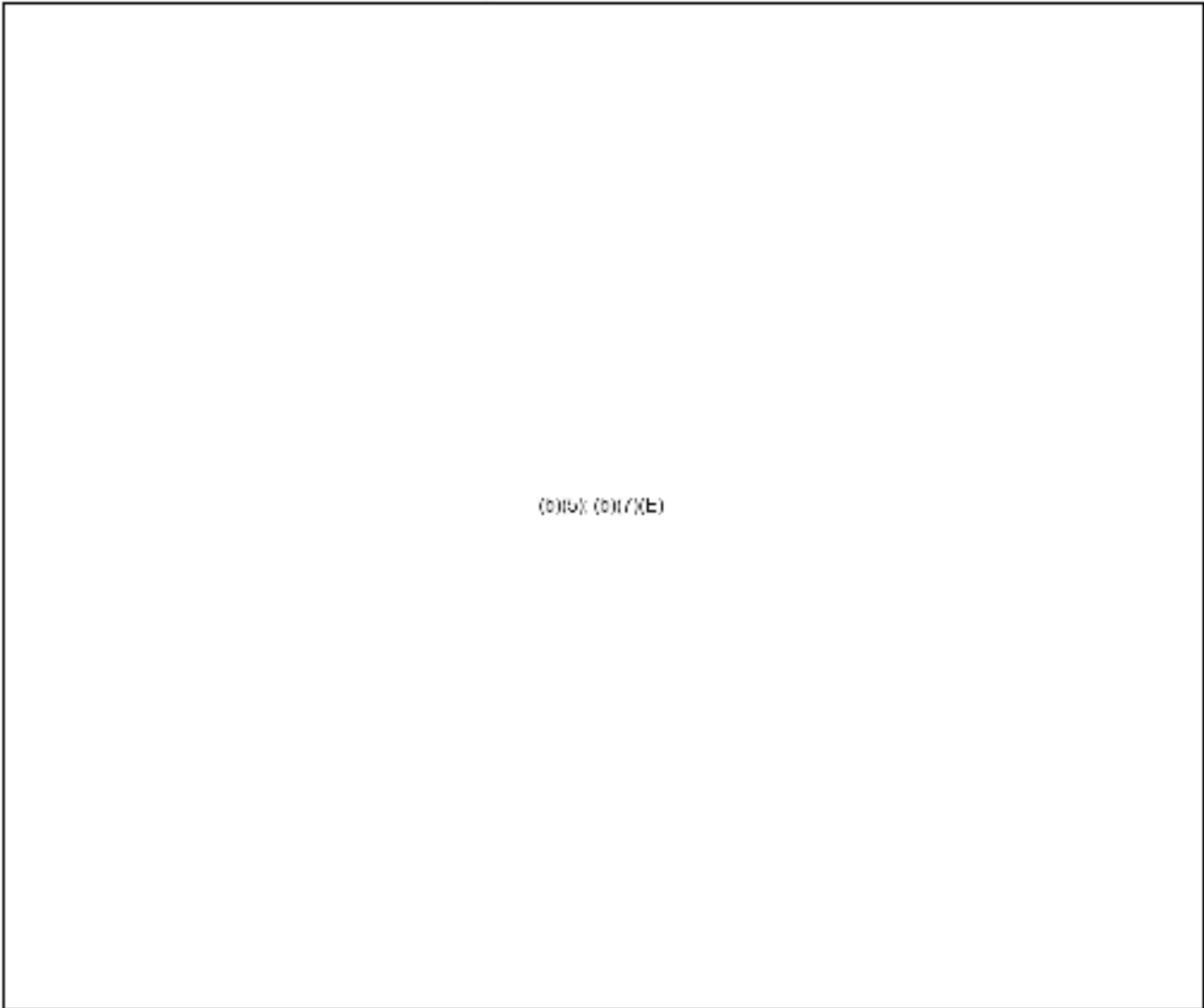

March for Trump

Background

Since the 2020 election, demonstrations have been organized nationwide advocating for President Trump and speaking out against the election results. In November 2020, a pro-Trump gathering in Washington, DC, resulted in an estimated **11,000** participants at Freedom Plaza, who marched to the Capitol and Supreme Court, and in December 2020, another pro-Trump gathering in Washington, DC, resulted in approximately **3,000** participants. The Pro-Trump protesters split between Freedom Plaza, the National Mall, the Capitol and the Supreme Court, with some individuals marching from one place to another, while others protested in one spot. The November and December demonstrations resulted in verbal and physical altercations between pro and anti-Trump demonstration groups, as well as numerous arrests. During the November 14, 2020, demonstration the Metropolitan Police Department (MPD) reported 21 arrests for assault, assault on a Police officer, possession of a weapon, disorderly conduct, and inciting violence. There were also seven firearms recovered by MPD during this event. The December 12, 2020, demonstration resulted in 33 arrests for assault on a police officer, simple assault, riotous acts, possession of a prohibited weapon (taser) and crossing a police line. MPD also reported during this event there were four people stabbed during an altercation, which included one MPD officer. All of the victims received non-life-threatening injuries and were treated and released.

Individuals continue to speak out against the 2020 presidential election results, and pro-Trump supporters have begun to organize another large-scale demonstration to occur on January 6, 2021. This is the day Congress is scheduled to certify the Electoral College vote for President-elect Joe Biden. As momentum for the demonstrations increased, President Trump tweeted to encourage his supporters to come to DC and protest, writing, "Be there, will be wild!" Individuals chose this tagline for the upcoming protest, naming it the "Wild Protest." The hashtag #WildProtest has been widely used to discuss and promote the event. President

Trump tweeted again on December 27, 2020, promoting the protest. As of December 30, 2020, social media indicated 5,989 participants plan to attend, and an additional 15,684 are interested.

Organizers

Stop The Steal (NRID), Million MAGA March (NRID), Women for America First (NRID), March for Trump (NRID), Proud Boys (RID), and other pro-Trump groups, along with private citizens, have promoted event pages for the event.

Stop The Steal is a loosely organized group which emerged on November 7, 2020, with the belief the election is being stolen from President Trump due to election fraud. The group began organizing demonstrations nationwide called "Stop The Steal." According to the website, invited speakers and featured guests for the January 6, 2021 event include Rep. Paul Gosar, Ali Alexander, Roger Stone, Rep-Elect Marjorie Greene, Rep. Lance Gooden, Rep-Elect Lauren Boebert, State Rep. Vernon Jones, State Rep. Mark Finchem, State Sen. Doug Mastriano, State Rep. Anthony Kern, and several others. One spokesperson from Stop The Steal, Ali Alexander (NRID), has encouraged followers to bring tents, sleeping bags, food, and water. Alexander claimed, "if DC escalates...so do we. Do not wear a mask. Stand with others bullied by staff." Twitter removed this tweet as it violated the spread of COVID-19 harmful information.

The Million MAGA March has been involved in organizing both large protests in November and December. The website was created early November prior to the first Million MAGA March, which spurred several social media groups and pages supporting this movement.

Women for America First is a pro-Trump, female led group. The group was the center of organization for both the November and December protests. The group plans to host a "March for Trump" bus tour from California to Washington, DC, arriving on the January 6, 2021.

Although March for Trump is listed as a group, several different smaller factions are listed under this name. The group name is considered more of a movement than an organization.

Proud Boys is a right-wing group founded in 2016 by Gavin McInnes as a "pro-Western fraternal organization." They are of record with USSS for demonstration activity since 2017; no civil disobedience or arrests have been recorded. For more information on the Proud Boys, please see the [Protective Intelligence Brief Proud Boys Talking Points](#).

Hotel Harrington, an alleged hangout/hotel for the Proud Boys, made a statement on December 28, 2020, announcing their closure from January 4-6, 2021, for "safety of visitors and employees." According to news media, four individuals were stabbed outside the hotel during the protests on December 12, 2020, when Proud Boys members clashed with counter protesters. Proud Boys' self-proclaimed chairman, Enrique Tarrio (NRID), made a statement on Parler regarding the closing of Hotel Harrington, claiming the Proud Boys outgrew the hotel and are planning on protesting during the January 4-6, 2021, time frame and will be staying at various other locations.

Call to Protest

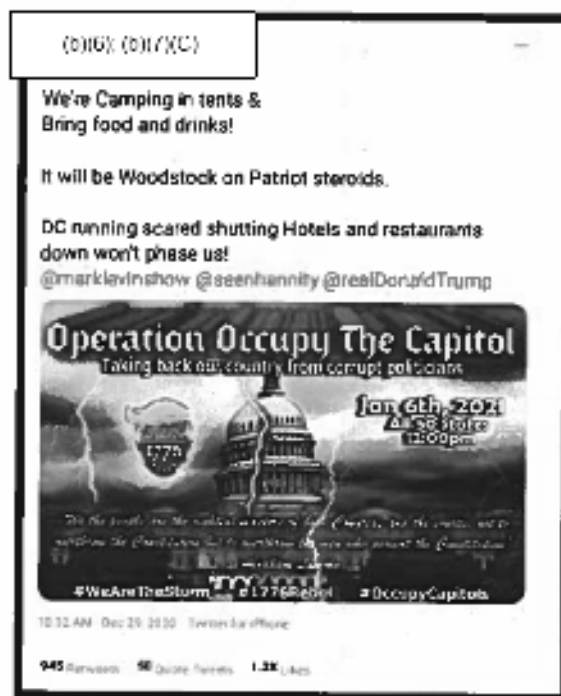
On January 6, 2021, a consortium of private citizens and pro-Trump groups reportedly will host the Wild Protest in Washington, DC. The groups intend to demonstrate in support of President Trump and speak

out against the 2020 election results. Numerous groups have claimed to be protesting at the US Capitol, with other groups protesting at the White House.

The hashtags #WeAreTheStorm, #1776Rebel, and #OccupyCapitols have gained attention as the protest on January 6, 2021 approaches. Commenters argue that other individuals were able to occupy other areas, including Black Lives Matter Plaza and the Capitol Hill Organized Protest/Capitol Hill Autonomous Zone, during separate protests, so President Trump supporters have proposed a movement to occupy Capitol Hill. This movement is supported by Ali Alexander's video requesting individuals to bringing tents, food, sleeping bags, and water (which has received over 300 comments and 2.5K retweets). Individuals who cannot come to Washington, DC, are encouraged to occupy their local capitols.

A website was located for chats and events related to the January 6th, 2021 DC Protest, titled *Maga Drag the Interstate*. Through this site, users are able to submit/create event caravan pages. All events are currently in reference to car and motorcycle caravans. There are currently 511 members for the "Jan 6 DC Caravan Planning" group with 47 events starting from all over the United States and reportedly ending in Washington, DC.



From January 4, 2021, at 10:00 AM to January 6, 2021, at 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "Carpool to Washington, DC" at the White House. The purpose of the event is to carpool from Texas and arrive in Washington, DC on 01/05/21. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 0 are interested.

From January 5, 2021, at 6:00 AM, to January 7, 2021, at 4:30 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "BTT heads to Washington DC for Trump Victory Rally" at the White House. The purpose of this event is to "rally for a Trump Victory." There is no indication of civil disobedience. According to Facebook, 7 people are going, and 26 are interested.

On January 5, 2021, at 6:30 AM to January 7, 2021, at 7:00 AM, the group *Muskegon County Republican Party (NRID)* will host an event called "Muskegon Bus to DC - Tyump Rally Jan 6th- Stop The Steal" at the US Capitol. The purpose of the event is to take a bus from Muskegon to Washington, DC to support President Trump. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 32 are interested.

From January 5, 2021, at 07:00 AM to January 7, 2021 at 7:00 AM, the group *Oakland County Republican Party (NRID)* will host a demonstration called "March For Trump" in Washington, D.C. The group plans to leave from Michigan on January 5th to arrive in Washington D.C. at 9:00 AM on January 6th. The purpose of this event is to join the pro-Trump demonstrations. Post

permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Participants are encouraged to bring flags and signs. Bus tickets are being sold for \$125 through Eventbrite. The group plans to stay in DC until 6:00 PM on January 6th. Facebook indicates 8 going and 16 interested.

On January 5, 2021, at 9:00 AM to January 12, 2021, at 9:00 AM, the individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Protect the POTUS" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, 3 people are going, and 8 are interested.

From January 5, 2021, at 10:00 AM, to January 6, 2021, at 08:00 PM, the individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "March on Congress Caravan" at 1st St SE, Washington, DC. The purpose of the event is to caravan to Washington, DC, from Florida, and support the United States and free and fair elections. There is no indication of civil disobedience. According to Facebook, 5 people are going, and 5 are interested.

On January 5, 2021, at 10:00 AM to January 7, 2021 at 2:00 AM, the group *The First Heavy Metal Church of Christ* (NRID) will host an event called, "Patriots Part 2020 in D.C." in Washington, DC. The group plans to caravan to DC, stay at the Grand Hyatt, and protest all day. The purpose of the event is to show support for the nation. There is no indication of civil disobedience. According to Facebook, 7 people are going, and 44 are interested.

On January 5, 2021, at 03:00 PM, the individual (b)(6), (b)(7)(C) (NRID) and the group *Trump-News-Joe Biden/Corruption-Watch* (NRID) will host a demonstration called "Maga Million Trump March Washington DC January 6th 2021" in Washington, D.C. Location specifics have not yet been released. The purpose of this event is to join the pro-Trump demonstrations. Post permissions for the discussion page have been turned off for guests. There is no indication of civil disobedience at this time. Facebook indicates 3 going and 3 interested.

On January 5, 2021, at 6:00 PM to January 6, 2021, at 9:00 PM, the group *Wisconsin Salt & Light Brigade* (NRID) and individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Stop the Steall" in Washington, DC. The purpose of the event is to "save our country from Biden/China tyranny!" There is no indication of civil disobedience. According to Facebook, 1 person is going, and 2 are interested.

On January 5, 2021, at 10:00 PM, the individual (b)(6), (b)(7)(C) (NRID) and the group *New Jersey Patriot Events* (NRID) will host a demonstration called "Washington DC 5th - 6th Trip" at the National Mall. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 148 people are going, and 354 are interested.

On January 5, 2021, at 10:00 PM to January 7, 2021, at 10:00 AM, the individual (b)(6), (b)(7)(C) (NRID) will host an event called "FREE bus trip DC for the Jan 6 protest!" in Washington, DC. The purpose of the event is to bus to Washington, DC to participate in the protest to support President Trump. There is no indication of civil disobedience. According to Facebook, 7 people are going, and 62 are interested. The discussion page posted the busses are full

On January 5, 2021, at 11:30 PM to January 6, 2021, at 8:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "Charter Bus to Trump Rally, DC" at the US Capitol. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook 18 people are going, and 99 are interested.

On January 6, 2021, at an unknown time, the *Proud Boys* (RID) will host an unnamed demonstration in Washington, DC. The purpose of this demonstration is to join the other pro-Trump demonstrations. There was no indication of civil disobedience. The group advised they will not wear their traditional black and yellow attire, and will dress "incognito." The group self-reported plans to demonstrate in smaller groups throughout DC. Current numbers of planned participants were not indicated, but the group stated they will "turn out in record numbers."

On January 6, 2021, at 12:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called "National Caravan for Trump 'Stop the Steal' Rally" at the US Capitol. The purpose of the event is to join the caravan to protest in Washington, DC. There is no indication of civil disobedience. According to Facebook, 1 person is going and 0 are interested. (#MidnightRide)

On January 6, 2021, at 1:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "We the people need transparency!" at the US Capitol. The purpose of the event is to "show up outside the US Senate in support of demanding our election is proven to be fair." There is no indication of civil disobedience. According to Facebook, 2 person is going, and 5 are interested.

On January 6, 2021, from 1:00 AM to 12:55 AM, the individual (b)(6); (b)(7)(C) (NRID) and group *Patriot Party of America (The Peoples Party)* (NRID) will host a demonstration called "Million MAGA Strong" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 3 people are going, and 14 are interested.

On January 6, 2021, from 4:00 AM to 11:45 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "CANTON/AKRON ELECTION PROTEST BUS TRANSPORTATION (SOLD OUT)" at the US Capitol. The group plans on leaving Canton, OH, and demonstrating in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 64 people are going, and 181 are interested.

On January 6, 2021, from 5:00 AM to 5:00 PM (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a rally at Freedom Plaza in Washington, DC called "Bus Trip to D.C. Last Rally for Freedom." The purpose of the event is to support President Trump and Vice President Michael Pence on this momentous day in history as Congress counts the Electoral College's votes. The page did not indicate there would be any civil disobedience. The page portrayed 14 participants and 42 interested.

On January 6, 2021, at 5:30 AM, the individuals (b)(6); (b)(7)(C) (NRID) and (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Jan 6th DC MAGA/KAG March-leaving from Fayetteville, NC" at the US Capitol. The group plans on arriving in Washington, DC, at 10 AM. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 19 people are going, and 42 are interested.

The purpose of the event is to "join together on this day. In support of our election." There is no indication of civil disobedience. According to Facebook, 1 person is going, and 1 is interested.

On January 6, 2021, at 9:00 AM, private citizen (b)(6); (b)(7)(C) (NRID) will host a demonstration at the National Mall called "President Trump's Calling on Patriots to Protest in Washington D.C. January 6th @ the National Mall." The purpose of this demonstration is to join the pro-Trump demonstrations as a contingency from Texas. There was no indication of civil disobedience. According to Facebook, 112 people are going, and 131 are interested.

On January 6, 2021, at 9:00 AM, the group *Therightside* (NRID) will host an event called "March for Trump" in Washington, DC. The purpose of the event is to show love and support for President Trump. There is no indication of civil disobedience. According to Facebook, 0 people are going, and 0 are interested.

On January 6, 2021, at 9:00 AM, the group *Joe Biden is not my president.* (NRID) will host a demonstration called "January 6th Patriots March In DC" in Washington, DC. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 0 people are going, and 0 are interested.

On January 6, 2021, at 9:00 AM, the *Trump Task Force 2020* (NRID) will host a protest titled "Protest the election of Joe Biden Washington D.C." at the United States Capitol. The purpose of the event appears to be "to stop the fraudulent election of Joe Biden." The page does not indicate there will be any civil disobedience; there are no comments on the page. Current numbers per Facebook depict 0 going with 1 interested.

On January 6, 2021, from 9:00 AM, the group *Frederick County Conservative Club* (NRID) will host a demonstration in Washington, DC, called "Million MAGA March." The purpose of this demonstration is to show support for President Trump. The group plans on arriving at Freedom Plaza from Frederick, MD, at 9:00 AM, and departing DC at 3:30 PM. There is no indication of civil disobedience. According to Facebook, 97 people are going, and 251 are interested.

On January 6, 2021, from 9:00 AM to 06:00 PM, the group *Prime Time Patriots* (NRID) will host a demonstration called "MARCH FOR TRUMP" in 213 Pennsylvania Ave SE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 106 people are going, and 534 are interested.

On January 6, 2021, from 9:00 AM to 7:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Calling all Patriots! We have been called to DC to the Nation's Capital for a Peaceful protest to save #America #StopTheSteal" in Washington, DC. The purpose of the

demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 85 people are going, and 139 are interested.

From January 6, 2021, at 9:00 AM to January 7, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Patriot Protest March" in Washington, DC. The purpose of the event is to "protest the election fraud, tyranny and corrupt politicians." There is no indication of civil disobedience. According to Facebook, 11 people are going, and 28 are interested.

On January 6, 2021, from 10:00 AM to 5:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Trump Rally Jan 6" in Washington, DC. The purpose of the event is to "come to DC Jan 6 when Congress counts electoral votes and objections are raised." There is no indication of civil disobedience. According to Facebook, 97 people are going, and 163 are interested.

On January 6, 2021, from 10:00 AM to 4:00 PM, the group *Stop the Steal (NRID)* will host a demonstration at the US Capitol called "Wild Protest." The purpose of this demonstration is to speak out against the 2020 presidential election results. There is no indication of civil disobedience. Current numbers of planned participants is unavailable at this time.

On January 6, 2021, at 10:00 AM, the group *Scranton Tea Party (NRID)* will host a demonstration called "Trump Washington Event" at the White House. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 39 are interested.

On January 6, 2021, at 10:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "COVID+ Freedom March" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 109 people are going, and 198 are interested.

On January 6, 2021, at 10:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called "Protest for Trump on Jan 6" at the US Capitol. On January 6, 2021, at 10:00 AM to 4:00 PM, the group *Fathers for Trump (NRID)* will host a demonstration called "Elector Rally" at The US Capitol. The purpose of the event is to rally at the

The purpose of the event is to demand the politicians to confirm Donald Trump as President. There is no indication of civil disobedience. According to Facebook, 148 people are going, and 206 are interested.

On January 6, 2021, at 11:00 AM, the individuals (b)(6), (b)(7)(C) (NRID) and (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Fight for Trump" at the US Capitol. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 6 people are going, and 13 are interested.

On January 6, 2021, at 11:00 AM, the individuals (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Stop The Steal Jan 6 Capitol Hill" at First St NE, Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 471 people are going, and 3.2K are interested.

On January 6, 2021, at 11:00 AM, the individual (b)(6), (b)(7)(C) (NRID) and the group *THE BASKET OF DEPLORABLE (NRID)* will host an event called "Jan 6th D.C. Maga March" in Washington, DC. The purpose of the event is to join "the largest Maga March Ever!" There is no indication of civil disobedience. According to Facebook, 12 people are going, and 29 are interested.

On January 6, 2021, at 11:00 AM, the individual (b)(6), (b)(7)(C) (NRID) will host a demonstration called "Donald Trump The BIG Protest Rally in Washington, D.C January 6th" in Washington, DC. The purpose of the event is to be in Washington, DC. There is no indication of civil disobedience. According to Facebook, 1 person is going, and 1 is interested.

On January 6, 2021, at 12:00 PM, the group *Washington State March for Trump in DC 01/06/2020 (NRID)* will host a demonstration called "MARCH FOR TRUMP" in Washington DC. The specific location has not been released. The purpose of the event is to show support for President Trump. There is no indication of civil disobedience. According to Facebook, there are 0 going, and 2 interested.

On January 6, 2021, at 12:00 PM, the group *Million MAGA March (NRID)* will host a demonstration at the National Mall in Washington, DC, called "Million MAGA March – Round III." The purpose of this demonstration is to show support for President Trump and speak out against the election results. The group is utilizing hashtags #millionmagamarch, #millionmagamarch2021, and #stopthesteal. There was no indication of civil disobedience. Their website last indicated 1,522 people are going. The website has since removed the number of participants.

On January 6, 2021, at 12:00 PM, the group *Patriot Party (NRID)* and private citizen (b)(6), (b)(7)(C) (NRID) will host a demonstration at the US Capitol called "Patriots United March on Congress." The purpose of the demonstration is to speak out for election integrity while Congress meets to confirm the Electoral College votes. The group indicates plans to meet at the Capitol, but has not indicated potential routes. There is no indication of civil disobedience. According to Facebook, 34 people are going, and 212 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and the group *Eighty Percent Coalition (NRID)* will host an event called "Rally to Save America" at Freedom Plaza. The purpose of the demonstration is to support President Trump. According to the website, confirmed speakers include Roger Stone, Julio Gonzalez, George Papadopoulos, Mark Burns, Greg Locke, and Bernard Kerik. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 11 are interested.

On January 6, 2021, at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) and groups *Virginia Women for Trump (NRID)*, *Keep Georgia Red (NRID)*, *TRUMPS FREEDOM FIGHTERS (NRID)*, *PRESIDENT DONALD TRUMPS SOLID SUPPORT WORLDWIDE (NRID)*, *Women United for Trump (NRID)*, *Trump/Pence Reelection Group (NRID)*, *Trump Daily Report (NRID)*, *TRUMP ~ The Next Four Years (NRID)*, and *GA Women for Trump (NRID)* will host a demonstration called "MARCH FOR TRUMP JANUARY 6TH WASHINGTON DC" in Washington, DC. The purpose of the demonstration is to support President Trump. There is no indication of civil disobedience. According to Facebook, 27 people are going, and 46 are interested.

On January 6, 2021, at 12:00 PM, an unknown group will host a demonstration titled "Operation Occupy The Capitol" in Washington, D.C. The purpose of the event is to "peacefully protest the election fraud." Participants are encouraged to protest at their state capitol if they are unable to travel to Washington D.C. There is no indication of civil disobedience at this time. The Twitter event hashtags are #WeAreTheStorm, #1776Rebel and #OccupyCapitols. Participant numbers are unknown as the event was located through flyer.

On January 6, 2021, at 12:00 PM, the group *South Florida Freedom Advocates (NRID)* will host an event called "Freedom March" at Freedom Plaza. The purpose of the event is to March in DC. There is no mention of civil disobedience. According to Facebook 0 people are going, and 1 is interested.

On January 6, 2021, at 12:00 PM, the group *Moore County Citizens for Freedom (NRID)* will host an event called "10 million MAGA MARCH" at Freedom Plaza. The purpose of the event is to support President Trump. There is no indication of civil disobedience. According to Facebook, 2 people are going, and 3 are interested.

On January 6, 2021, at 12:00 PM, the group *RiseUP Revolution: Welcome To The Patriot Party (NRID)* will host an event called "Fight For America" at 1455 Pennsylvania Ave SE. The purpose of the event is to Rally to fight for America. There is no indication of civil disobedience. According to Facebook, 0 people are going, and 3 are interested.

On January 6, 2021, at 12:00 PM, *The Patriot Party (NRID)* will host an event called "Maga Rally" in Washington, DC. The purpose of the event is to support President Trump. There is no chatter on the page, nor any indication of civil disobedience. Current numbers per Facebook, 6 going with 10 interested.

Counter Demonstrations

There are several counter-demonstrations planned for January 6, 2021. OSB has observed less social media activity and chatter for these counter-demonstrations than during previous pro-Trump demonstrations. The themes emerging from social media chatter amongst the counter protestors is similar to the rhetoric espoused during prior protests; the groups are attempting to keep Proud Boys and other Pro-Trump groups out of Washington, DC.

Several local groups have shared the news regarding Hotel Harrington closing from January 4-6, 2021, and have encouraged followers to contact other local hotels to encourage them to shut down as well. Although *ShutDownDC (RID)*, *All Out DC (RID)*, and *Black Lives Matter DC (RID)*, have shared the news regarding Hotel Harrington on social media, they have not publicly announced any details regarding plans to protest.

On January 6, 2021, at an unknown time, the group *Refuse Fascism (RID)* will host a demonstration in Washington, DC, called "Opposing Trump's Moves to Overturn the Election." The purpose of this demonstration is to speak out during the pro-Trump demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On January 6, 2021, at an unknown time, the groups *They Them Collective (RID)*, *Total Liberation Collective (NRID)*, *DC Protests (NRID)*, *Good TroubleCo.op (NRID)*, *Smash the Fash NOVA (NRID)*, and *DC Youth Liberation Front/DCYLF (RID)* will host a demonstration in Washington, DC, called

"Alert: Terrorists in Town Jan 3-6, 17-23." The purpose of this demonstration is to counter demonstrate during the Proud Boys and Stop the Steal demonstrations. There is no indication of civil disobedience. Current numbers of planned participants are unknown at this time.

On 01/06/21, at an unknown time, the group *DC Protests (NRID)* will host a demonstration with an unknown title in Washington, DC. The purpose of the event is to form a bike line to "protect against the armed right-wing extremist groups." The group plans on forming a bike line using bikes, boards, and wheels. The specific location was not provided. There is no indication of civil disobedience. Participant numbers were not available.

On January 6, 2021, from 12:00 PM to 3:00 PM, the group *I Approve This Message (NRID)* will host a demonstration at the US Capitol Building called "Donald, You're Fired! March on DC." The purpose of the demonstration is to "witness this momentous occasion. Upon the declaration of the results of the 2020 elections, held on November 3rd, 2020, We the People will proceed, peacefully and safely, from the Capitol Building to the White House to deliver the message to Mr. Trump, Donald Trump, You're Fired!" There is no indication of civil disobedience. According to Facebook, 8 people are going, and 26 are interested.

On January 6, 2021, at 1:00 PM, the groups *Insurgence USA (NRID)* and *Protest Live (NRID)* will host a demonstration in Washington, DC, called "No Fascist in DC – March Against Fascism." The group intends to meet at the Washington Monument. The purpose of this demonstration is to speak out against fascism. There is no indication of civil disobedience. According to Facebook, 9 people are going, and 80 are interested.

Refuse Fascism has demonstrated on numerous occasions at the White House and temporary protected sites. One demonstration in 2017, held near Trump Tower in New York City, ended with arrests for disorderly conduct and failure to obey.

TheyThem Collective is of record for a demonstration at the White House in November 2020. The demonstration concluded without incident or arrest.

DC Youth Liberation Front is of record with the USSS for a demonstration in August 2020 near Meridian Park. The group utilized sound equipment and MPD made several arrests for damaging 30 vehicles, destroying two police cruisers, defacing government property, setting fires, and breaking windows.

ShutDownDC has demonstrated on numerous occasions in relation to social justice in Washington, DC, as well as outside Acting DHS Secretary Chad Wolf's home. A ShutDownDC demonstration on June 2, 2020, resulted in one arrest for possession of an imitation pistol and a BB gun.

All Out DC is of record with the USSS for numerous demonstrations at the White House. During an All Out DC demonstration in June 2020, protestors were observed using fireworks, obstructing roads, and throwing debris at officers. MPDC used smoke to clear the area and the demonstration concluded with one arrest for threats.

Black Lives Matter has demonstrated on numerous occasions at the White House and temporary protected sites. The group has previously used sound equipment. One demonstration on June 4, 2020, concluded with one arrest after gas cans and fireworks were observed inside a subject's vehicle. Two

arrests were made during a demonstration on June 2, 2020, for possession of an imitation pistol and possession of a BB gun.

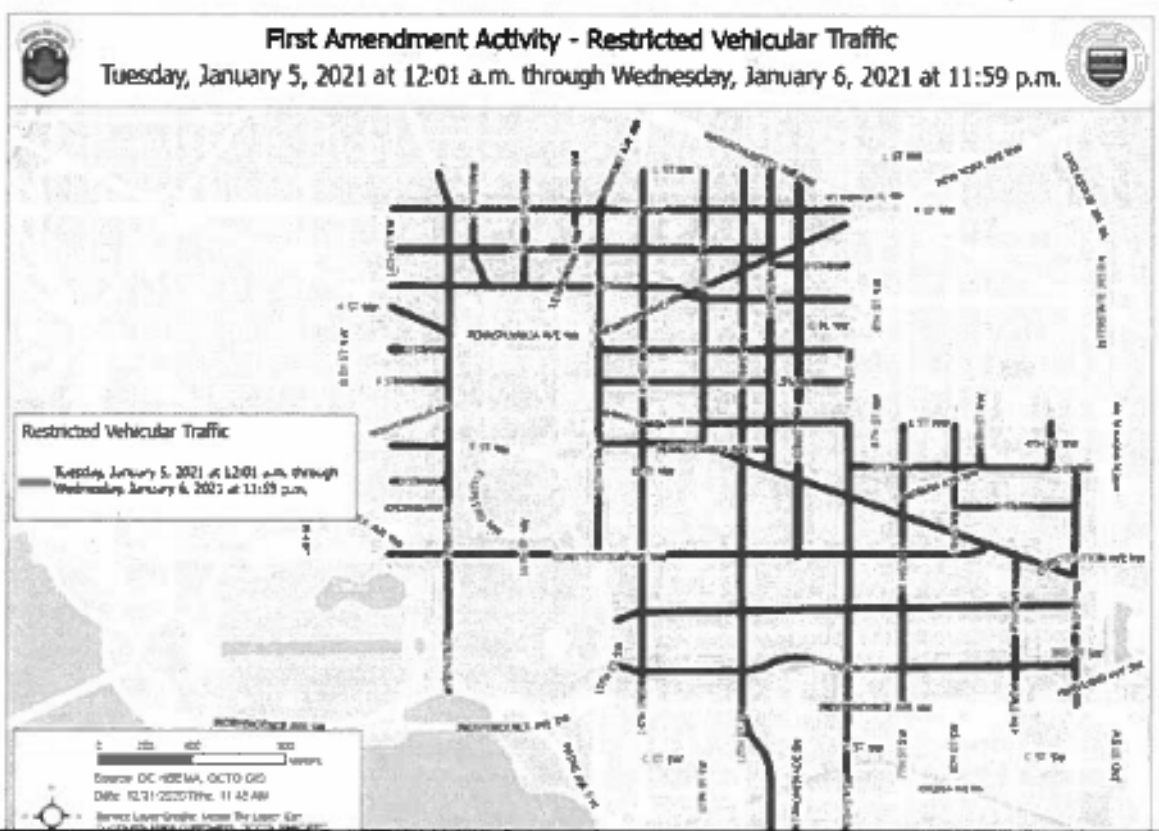

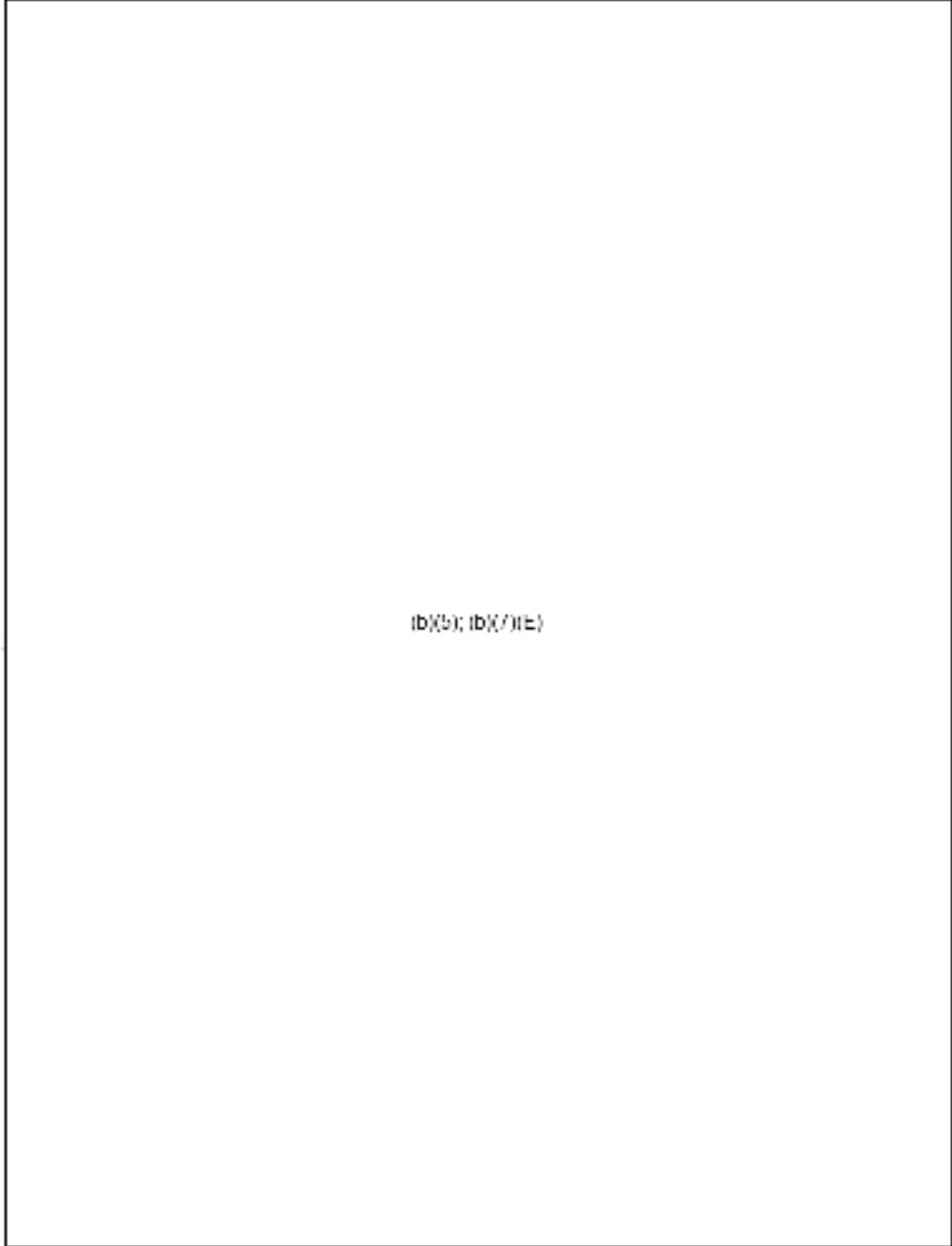

Assessment

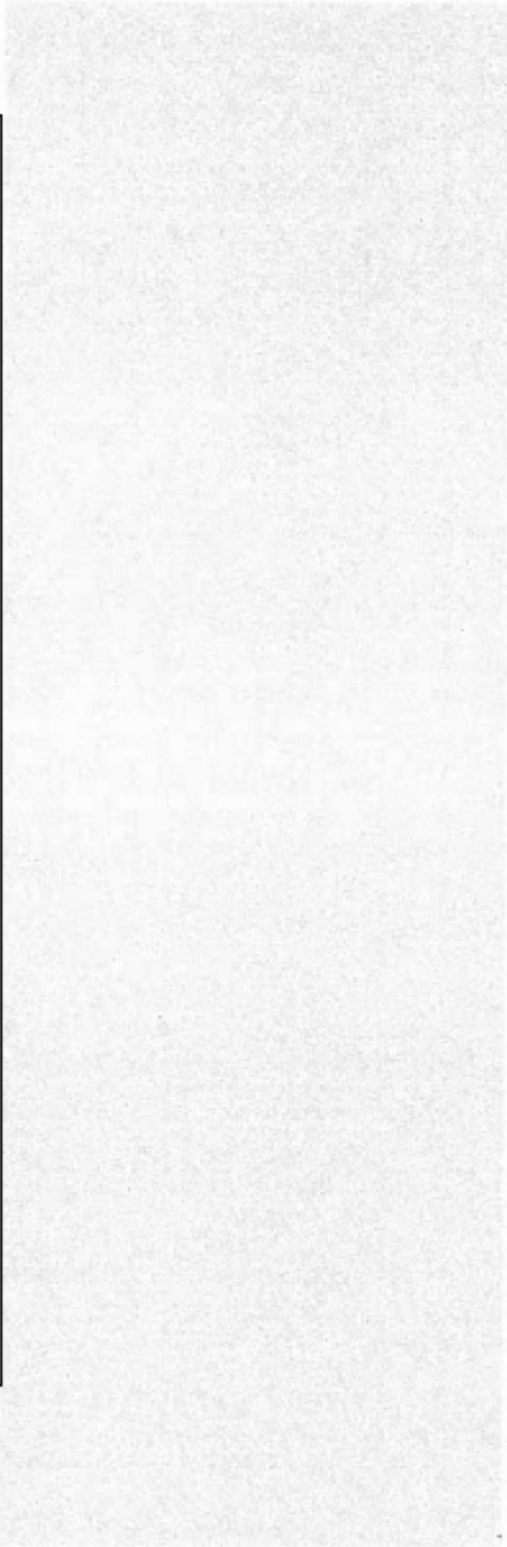
