RC Explains the LAPROA Legal Defense Fund

As the year rapidly comes to a close, I wanted to take this opportunity to talk to you about some important but somewhat confusing and misunderstood subjects: The Legal Defense Fund and Insurance. All members of the Lake Arthur Police Reserve Officers Association (LAPROA) have access to a Legal Defense Fund financed by our LAPROA membership dues.

The LAPROA Legal Defense Fund provides you with legal representation for any on-duty incident which results in the need for legal counsel or representation. Incidents that may require legal defense include, but are not limited to, use of force situations during which you deploy a firearm, less lethal device, or direct physical force. If you are involved in an on-duty use of force incident you will potentially have both criminal and civil legal issues to deal with. Such incidents almost always involve an investigation by local prosecutors and an internal Agency investigation. A Legal Defense Fund means you will have a lawyer represent you for specified criminal and civil liability you may be facing related to your critical

The LAPROA Legal Defense Fund is administered through the Kubiak Law Firm in Albuquerque, New

Mexico. Should you be involved in any type of critical incident, you will receive immediate legal representation and advice with just a phone call or e-mail notification to Simon and his legal staff. The LAPROA does not pay a retainer or fees of any kind for the Legal Defense Fund. The Fund is maintained in its entirety in anticipation of any potential legal needs of our members.

Insurance is totally different from a Legal Defense Fund. Plans provide a source of funds if you suffer a loss (such as a civil iudgment against you). The terms and conditions of every plan vary As most of us carry a firearm off-duty, you should consider additional private "Concealed Carry" and "Self Defense" insurance for off-duty incidents. Many officers assume that homeowners, renters, or umbrella insurance will cover us. That is not the case. Most policies do not cover your police work! There are a number of great insurance plans on the market: CCW Safe, United States Concealed Carry Association, NRA Guard Carry, Armed Citizens Legal Defense Network, and Second Call Defense, to name a few. Although these plans can be expensive, you will want as much protection as possible when your

freedom and everything you own is on the line.

The Legal Defense Fund provided by the LAPROA and any additional CCW/Self Defense Insurance you may purchase will be well worth it if you should find yourself in critical incident! "Self Defense" and "Concealed Carry" Insurance is highly recommended, but not provided by the LAPROA at this time.

Please remember that if you involve yourself in a use of force situation while off-duty and out of your jurisdiction, you do so as a private citizen under the common law doctrine of the "Good Samaritan" (PERS-505.00), and NOT as a law enforcement officer, and you should do so only as a last resort and when the safety of vourself or another citizen is in grave danger (is there another kind?). Such actions are outside the scope of your service as a LEO, and in such cases CCW/Self-Defense insurance will be an invaluable investment
