After receiving an update from FPS mirroring the info provided to the IMC below, GSA made the decision to close the facility out of an abundance of caution based on the number of demonstrators outside the main entrance and the presence of a small number of demonstrators in the lobby. We currently have cited and released several of the demonstrators who refused to leave the lobby once the building was close, with a few remaining to be processed. Those inside and outside have been generally peaceful. FPS has adequate personnel onsite to handle the current situation and there is also a large Boston Police presence outside the facility. Local media is also onsite.

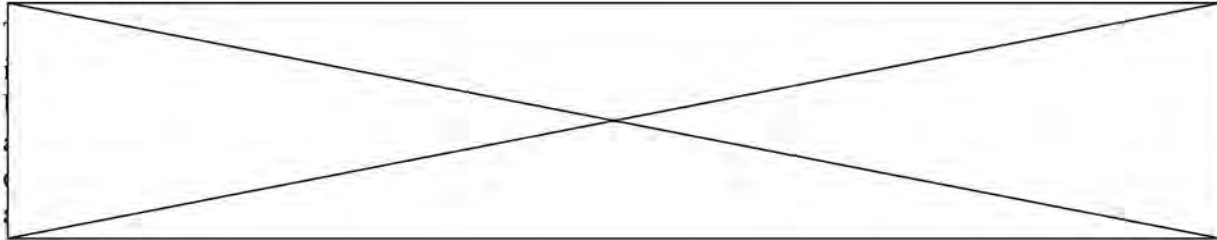

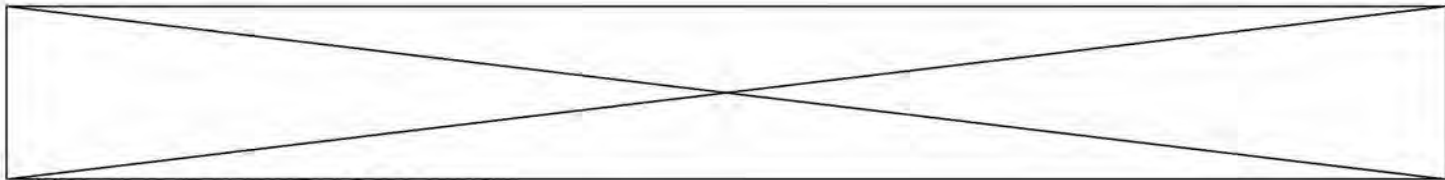

Just to reiterate, there is a demo occurring at the Capitol complex tomorrow. This does not directly affect our equities but depending on the size of the event, there could be spill over. I am guessing that the Sergeant At Arms sending out this distro means they are expecting a significant number of participants. I am assessing there to be a more fervent response because of rapidly deteriorating conditions in the Middle East, and the volume of demonstrations we have seen here so far since this all began. Additionally, if anyone has not listened to the news today, a hospital in Gaza exploded and the IDF is being blamed pretty heavily across the news and social media. What actually happened is still up for a thorough investigation but this has the potential to stir emotions even more so than they are already.

The President was planned to meet with the President of The Palestinian Authority and The King of Jordan, both of these meetings were immediately cancelled. Sentiment regarding US involvement on the side of the IDF is also cause for serious consternation and it seems to be getting worse over time. Just want to make everyone aware again for situational awareness.

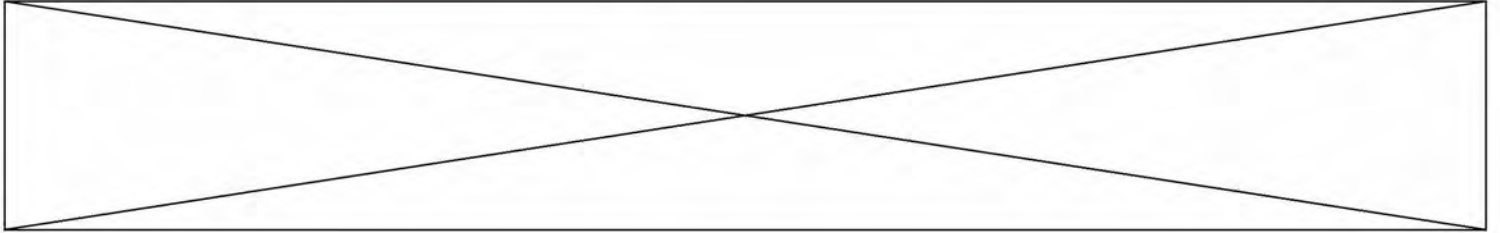

~~(b)(7)(F)~~ FPS reported this evening on several impacts to Federal facilities, many of which house the district offices of Members of Congress. In Boston, MA, the JFK Federal Building closed early today due to protests in the vicinity. In Chicago, IL, an altercation at a demonstration outside of the Kluczynski Federal Building resulted in Chicago Police pursuit of a suspect. In Detroit, MI, four federal facilities were closed and barricaded in anticipation of demonstrations. Detroit Police Department has increased its presence in the area. All federal employees were urged to leave the four facilities in Detroit and all vehicles have been moved to a safe location off property. Demonstrations near the Cannon House Office Building in Washington, DC, resulted in arrests by US Capitol Police. As a result, access to the Capitol grounds was restricted. Good morning,

Please see the below list of activities scheduled through this weekend. Because of current world events, there is an increased likelihood of demonstration activity affecting FPS protected facilities in the NCR. The current situation is rapidly evolving so I will do my best to keep everyone informed using available information. At this time, there is no information identifying credible, direct threats to FPS protected facilities; however, there is a risk of violent counteraction stemming from these events (see attached assessment). It is important to note, the below list of demonstrations contains First Amendment Protected Activities and were permitted through MPD. I am currently unaware of additional, non-permitted activities which may occur in the NCR. Cities across the U.S. are instituting additional protective measures because of a recent call to action which is summarized below.

Sharing this assessment from FPS (b)(7)(E)

The former leader and founding member of Hamas, Khaled Mashal, released a video message, calling for global jihad on October 13<sup>th</sup>, 2023, labeling it "the Friday of Al-Aqsa flood." Mashal also called for the mobilization of the Muslim community in support of Palestinians, directed Muslims worldwide to show anger toward Zionists (those that support Israel) and America, including attacks targeting Israelis and Americans, and encouraged martyrdom. This video has since been removed from YouTube.

- (b)(7)(E) have not identified any credible threats to the homeland. (b)(7)(E) (b)(7)(E) has not identified any threats from DVEs or FTOs despite observed rhetoric related to this call to action on social media and public messaging channels. No additional threat information was reported from the (b)(7)(E)
- DHS is reporting increased security around faith-based locations and airports in major cities in the US and around the world.

FPS Analyst Note: There are currently no direct credible threats to FPS-protected facilities; however, lone wolf attacks and large-scale demonstrations have the potential to indirectly impact federal facilities. Previous call to actions from Mashal did not result in any violence, therefore, the current threat is not being treated as credible by the (b)(7)(E). However, the current threat environment and ongoing bloodshed in Israel and Palestine suggests a greater likelihood of violence. The FPS (b)(7)(E) will continue to (b)(7)(E) as it relates to tomorrow's call to action.

Unaware of any credible threats of violence in Maryland. Have done extensive outreach and are concerned about potential for RMVE activity. There is an event planned at Frederick Community College this weekend that is pro-Israel, it may be supported by known White Supremacists. The events they have had in MD so far have been small and they believe the events this weekend will be small also (100 or fewer attendees). They anticipate ongoing peaceful first amendment protected events in coming weeks.

**(b)(7)(E)**

No known threats or concerns specific to NOVA. Have had both pro and against protests – largest was 200 people. No issues with violence or criminal activity. Had a report of suspicious activity of a person attempting to enter a synagogue that they are investigating. They anticipate ongoing peaceful first amendment protected events in coming weeks.

**(b)(7)(E)**

Briefed that they have handled a good number of peaceful first amendment protected events since 10/7, most in support of Hamas or Palestinians, or critical of impending Israeli military action. These events have been large, and drawn more attendance than expected, and have been very well organized. There have been spontaneous demonstrations at synagogues and other facilities following the larger planned events. The Pro-Israel events have been

smaller vigil type of events. Many of the events in DC have not been permitted, increasing the difficulty of planning for them.

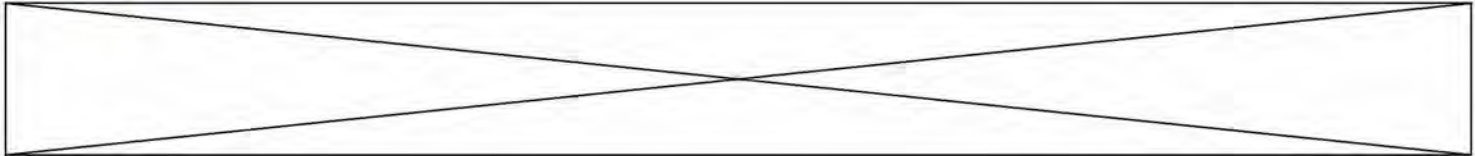
