# Bloomberg US Treasury 7-10 Year Laddered Index

The rules of the Bloomberg US Treasury 7-10 Year Laddered Index are described in the <u>Bloomberg US Treasury Index</u> ("Parent Index") with the exception of the security selection process and equal-weighting structure described below. These documents collectively constitute the index methodology for this Index.

The Bloomberg US Treasury 7-10 Year Laddered Index tracks USD-denominated, US Treasury securities with maturities between 7 and 10 years. The securities contained in the index are a subset of the parent index <u>Bloomberg US Treasury Index</u>. The index was created in January 2024.

# **Features Specific to this Index**

**Security Selection** The securities in the index are reconstituted quarterly at the close of February, May, August, and

November. One Treasury security is selected from each maturity month between 7 and 10 years. The maturity months used for selection are February, May, August, and November, which is inline with the US Treasury refunding schedule. If there are two or more securities within a given maturity month, then the most recently issued security is selected. This process implies that there will be 12 securities in the index at each reconstitution (unless a given maturity month has no eligible securities). It is

possible that a given maturity month will not contain a security.

Maturity At least 7 years and up to, but not including, 10 years until final maturity.

**Security Weighting** The securities in the index will be equally weighted at each month-end. From those equal market

value weights, the notional values for each security will be derived. These notional values will be used

for the following month's return calculation.
