We wanted to provide the IG community with some specific information about the scope of OIGs that were impacted by the IG termination notices received last weekend.

As you may know, there are currently 37 Federal OIGs that require a Presidentially Appointed, Senate Confirmed (PAS) IG. Of the 37 PAS IG positions, 11 of those positions were vacant as of January 24, 2025, meaning 26 PAS IG positions were filled.

Of the 26 PAS IGs in place last week, 15 received termination notices from the White House. Three other OIGs that had interim leadership were also impacted.

In all, the termination notices impacted 18 OIGs, including: Department of Agriculture, Department of Commerce, Department of Defense, Department of Education, Department of Energy, Department of Health & Human Services, Department of Housing and Urban Development, Department of the Interior, Department of Labor, Department of State, Department of Transportation, Department of the Treasury, Department of Veterans Affairs, Environmental Protection Agency, Office of Personnel Management, Small Business Administration, Social Security Administration, and Special Inspector General for Afghanistan Reconstruction.


As a result, 11 of the 37 PAS OIGs are currently led by a permanent IG. For a full accounting of the current IG vacancies, please visit Oversight.gov.



ORDER OF SUCCESSION AND DESIGNATION TO ACT

<u>Authority:</u> Inspector General Act of 1978, as amended, 5 U.S.C. §§ 401-424; Presidential Policy Directive 40, National Continuity Policy, July 15, 2016; Federal Continuity Directive 1, Federal Executive Branch National Continuity Program and Requirements, January 2017; and SECR 29-1.

<u>Purpose:</u> To provide an order of succession for executive continuity of the Securities and Exchange Commission Office of Inspector General (SEC OIG) during periods of national emergency. To provide an order of succession in the event the Inspector General is temporarily or permanently unable to perform the functions and duties of the position by reason of absence, illness, death, resignation, termination, or other causes. This order supersedes the previous SEC OIG Order of Succession and Designation to Act dated March 26, 2020.

1. Continuity of Operations

During periods of national emergency declared by the President, or in situations in which the SEC OIG's Continuity of Operations Plan has been activated, the principals occupying the following positions will, in the order stated, assume operational management of the SEC OIG in the absence¹ of the Inspector General:

Counsel to the Inspector General

Deputy Inspector General for Audit, Evaluations and Special Projects

Deputy Inspector General for Investigations

Deputy Inspector General for Operations and Management

This succession will be followed by the Deputy Counsel to the Inspector General, followed in order of seniority in the position, by the Audit Managers, followed in order of seniority in the position, by Special Agents in Charge for Investigations, followed by the Supervisory Program Analyst in the Office of Operations and Management.

2. Vacancies

Notwithstanding section 1, in cases where there is a vacancy in the position of Inspector General, including cases in which the incumbent dies, resigns, or is otherwise unavailable to perform the functions and duties of the position in the foreseeable future, the principals occupying the following positions shall perform the functions and duties of the Inspector General temporarily in an acting capacity in the order stated:

Counsel to the Inspector General

Deputy Inspector General for Audit, Evaluations and Special Projects

Deputy Inspector General for Investigations

Deputy Inspector General for Operations and Management

¹ For the purpose of this section, absence is defined as the temporary absence, illness, or other inability to perform the functions and duties of the position.

This succession will be followed by the Deputy Counsel to the Inspector General, followed in order of seniority in the position, by the Audit Managers, followed, again in order of seniority in the position, by the Special Agents in Charge for Investigations, followed by the Supervisory Program Analyst in the Office of Operations and Management.

3. Absences

If the Inspector General is absent, sick or otherwise temporarily unavailable to perform his or her duties, operational management of the SEC OIG will devolve upon the persons and in the order described in section 2, unless otherwise designated by the IG.

4. Delegation of Authority and Duration

The individual assuming operational management of the SEC OIG under sections 1-3 is delegated all authorities and responsibilities of the IG until one of the following, as applicable: termination of the period of national emergency declared by the President or termination of the SEC OIG's Continuity of Operations Plan under section 1; the permanent IG is able to perform the functions and duties of the office; replacement by an official appointed as IG pursuant to Section 8G(c) of the Inspector General Act of 1978, as amended; or the individual is otherwise relieved of the duty of serving as the acting IG.

5. Sub-delegation

The authority delegated in section 4 may not be sub-delegated.

6. Vacancies and Acting Officials

For purposes of this delegation order, the principal occupying the position is the person holding a permanent appointment to the position. Persons filling the positions in an acting capacity due to a short-term absence (e.g., principal is on annual leave) or a long-term vacancy (e.g., principal has separated or is on extended leave) do not substitute for principals. If a position is vacant or a principal occupying the position is absent or unavailable, authority passes to the next principal in the order of succession.

7. Notification of Appropriate Personnel

Situations requiring activation of this policy will be communicated electronically to all OIG SK-17s. The SK-17s are responsible for notifying OIG employees under their supervision, if appropriate.






