

Bloomberg Emerging Asia (ex China) USD Select Bond Index

The rules of this Index are described in the [Bloomberg Emerging Markets USD Aggregate Bond Index](#) ("Parent Index") with the exception of the "Features Specific to this Index" described below. These documents collectively constitute the index methodology for this Index.

The Bloomberg Emerging Asia (Ex China) USD Select Bond Index tracks the performance of fixed-rate USD-denominated government related bonds and corporate bonds of the Emerging Market Asia ex China region, while limiting the high yield exposure to 15%. For inclusion, government related bonds must have at least eight years to maturity and corporate bonds must have at least 1 year to maturity. The index also excludes 144a securities that do not also have a RegS tranche. The index was created in February 2019, with history backfilled to June 2013.

Features Specific to this Index

Country	Emerging market countries in Asia excluding China
Coupon	Fixed-rate bullet bonds only
Credit Rating	Securities must be rated Ba3/BB-/BB- or higher using the middle rating of Moody's, S&P and Fitch; when a rating from only two agencies is available, the lower is used; when only one agency rates a bond, that rating is used.
Maturity	<ul style="list-style-type: none"> Government-related bonds must have at least 8 years to maturity Corporate bonds must have at least 1 year to maturity
Market of Issue	<ul style="list-style-type: none"> SEC-Registered bonds and debt issued under Rule 3(a)(2), which is exempt from registration with SEC, are index eligible. 144A securities that do not also have a Reg-S tranche are excluded.
High Yield Capping	High yield bonds that exceed 15% of the market value of the uncapped Emerging Asia (ex China) USD Select Bond Index are limited at 15%. The excess market value over the 15% cap is redistributed on a pro rata basis to all other investment grade bonds.
