To be eligible for the index, bonds must have at least 20 years remaining to maturity and be rated at least AA3 or higher. The index was launched in August 2007, with index history available from January 1, 1999.

Minimum Amount Outstanding	EUR 300mn minimum par amount outstanding
Maturity	Securities with at least 20 years remaining to maturity, regardless of optionality.
Minimum Liquidity Requirements	See Minimum Amount Outstanding specified above
Rebalance Date	Monthly
